A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2005 – Wicomico County –**
3 **Salisbury Area Chamber of Commerce**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005
5 to authorize the matching fund to include real property; extending the deadline
6 by which the grantee is required to present evidence to the Board of Public
7 Works that a matching fund will be provided; and generally relating to the
8 Maryland Consolidated Capital Bond Loan of 2005 and the Salisbury Area
9 Chamber of Commerce.

10 BY repealing and reenacting, with amendments,
11 Chapter 445 of the Acts of the General Assembly of 2005
12 Section 1(3) Item ZA01 (BR)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

1 (BR) Salisbury Area Chamber of Commerce. Provide a grant
2 equal to the lesser of (i) \$100,000 or (ii) the amount of
3 the matching fund provided, to the Board of Directors of
4 the Salisbury Area Chamber of Commerce, Inc. for the
5 planning, design, repair, renovation, construction,
6 reconstruction, and capital equipping of the Salisbury
7 Area Chamber of Commerce building, located in
8 Salisbury. Notwithstanding Section 1(5) of this Act, the
9 matching fund may consist of funds expended prior to
10 the effective date of this Act **AND REAL PROPERTY.**
11 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT,**
12 **THE GRANTEE HAS UNTIL JUNE 1, 2009, TO**
13 **PRESENT EVIDENCE THAT A MATCHING FUND WILL**
14 **BE PROVIDED** (Wicomico County) 100,000

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 June 1, 2007.
