## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Montgomery County –**  
3 **Montgomery Village and Germantown Boys & Girls Club**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006  
5 to change the purpose of a grant to the Board of Directors of the Montgomery  
6 Village Foundation and to reduce the amount of the grant; amending the  
7 Maryland Consolidated Capital Bond Loan of 2006 to provide a grant to the  
8 Board of Directors of the Boys & Girls Clubs of Greater Washington, Inc. for  
9 certain development and improvement purposes; and generally relating to the  
10 Maryland Consolidated Capital Bond Loan of 2006, the Montgomery Village  
11 Foundation, and the Germantown Boys & Girls Club.

12 BY repealing and reenacting, with amendments,  
13 Chapter 46 of the Acts of the General Assembly of 2006  
14 Section 1(3) Item ZA01 (BJ)

15 BY adding to  
16 Chapter 46 of the Acts of the General Assembly of 2006  
17 Section 1(3) Item ZA01 (BJ–2)

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That:

3 (3) ZA01 LOCAL SENATE INITIATIVES

4 [(BJ)] Montgomery Village Foundation. Provide a grant  
5 **(BJ-1)** equal to the lesser of (i) \$250,000 or (ii) the amount  
6 of the matching fund provided, to the Board of  
7 Directors of the Montgomery Village Foundation,  
8 Inc. for the [planning, design, construction, repair,  
9 renovation, reconstruction, and capital equipping]  
10 **PLANNING AND DESIGN** of improvements to the  
11 Lake Whetstone facilities, located in Montgomery  
12 Village (Montgomery County) ..... [250,000] **25,000**

13 **(BJ-2) GERMANTOWN BOYS & GIRLS CLUB. PROVIDE**  
14 **A GRANT EQUAL TO THE LESSER OF (I) \$225,000**  
15 **OR (II) THE AMOUNT OF THE MATCHING FUND**  
16 **PROVIDED, TO THE BOARD OF DIRECTORS OF**  
17 **THE BOYS & GIRLS CLUBS OF GREATER**  
18 **WASHINGTON, INC. FOR THE CONSTRUCTION**  
19 **OF A GYMNASIUM AT THE GERMANTOWN**  
20 **BRANCH OF THE BOYS & GIRLS CLUBS OF**  
21 **GREATER WASHINGTON, LOCATED IN**  
22 **GERMANTOWN. NOTWITHSTANDING SECTION**  
23 **1(5) OF THIS ACT, THE MATCHING FUND MAY**  
24 **CONSIST OF IN KIND CONTRIBUTIONS**  
25 **(MONTGOMERY COUNTY) ..... 225,000**

1           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
2   June 1, 2007.
