1 AN ACT concerning

2 **Child Fatality Review Teams - Access and Disclosure of Information**

3 FOR the purpose of authorizing a certain local team to investigate certain information
4 and records; requiring that a certain local team be immediately provided access
5 to certain information and records maintained by a health care provider
6 regarding a child convicted of a crime or ~~convicted of a crime~~ adjudicated as
7 having committed a delinquent act that caused a certain death or fatality;
8 requiring that a certain local team be immediately provided access to all
9 information and records maintained by any State or local government agency
10 that provided services to a certain child or family; prohibiting the identification
11 of a child convicted of a crime or ~~convicted of a crime~~ adjudicated as having

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article – Health – General**

14 5-706.

15 (a) The purpose of the local team is to prevent child deaths by:

16 (1) Promoting cooperation and coordination among agencies involved
17 in investigations of child deaths or in providing services to surviving family members;

18 (2) Developing an understanding of the causes and incidence of child
19 deaths in the county;

20 (3) Developing plans for and recommending changes within the
21 agencies the members represent to prevent child deaths; and

22 (4) Advising the State Team on changes to law, policy, or practice to
23 prevent child deaths.

24 (b) To achieve its purpose, the local team shall:

25 (1) In consultation with the State Team, establish and implement a
26 protocol for the local team;

27 (2) Set as its goal the investigation of child deaths in accordance with
28 national standards;

29 (3) Meet at least quarterly to review the status of child fatality cases,
30 recommend actions to improve coordination of services and investigations among

1 member agencies, and recommend actions within the member agencies to prevent
2 child deaths;

3 (4) Collect and maintain data as required by the State Team;

4 (5) Provide requested reports to the State Team, including discussion
5 of individual cases, steps taken to improve coordination of services and investigations,
6 steps taken to implement changes recommended by the local team within member
7 agencies, and recommendations on needed changes to State and local law, policy, and
8 practice to prevent child deaths; and

9 (6) In consultation with the State Team:

10 (i) Define “near fatality”; and

11 (ii) Develop procedures and protocols that local teams and the
12 State Team may use to review cases of near fatality.

13 **(C) IN ADDITION TO THE DUTIES SPECIFIED IN SUBSECTION (B) OF THIS**
14 **SECTION, A LOCAL TEAM MAY INVESTIGATE THE INFORMATION AND RECORDS**
15 **OF A CHILD CONVICTED OF A CRIME OR ADJUDICATED AS HAVING COMMITTED A**
16 **DELINQUENT ACT THAT CAUSED A DEATH OR NEAR FATALITY DESCRIBED IN §**
17 **5-707 OF THIS SUBTITLE.**

19 Upon request of the chair of the local team and as necessary to carry out the
20 local team’s purpose and duties, the local team shall be immediately provided:

21 [(1) By a provider of medical care, including dental and mental health
22 care, with access to information and records regarding a child whose death is being
23 reviewed by the local team, including information on prenatal care; and]

24 **(1) ACCESS TO INFORMATION AND RECORDS, INCLUDING**
25 **INFORMATION ON PRENATAL CARE, MAINTAINED BY A HEALTH CARE PROVIDER**
26 **REGARDING:**

27 **(I) A CHILD WHOSE DEATH IS BEING REVIEWED BY THE**
28 **LOCAL TEAM; OR**

1 **(II) A CHILD CONVICTED OF A CRIME OR ~~CONVICTED OF A~~**
2 **CRIME ADJUDICATED AS HAVING COMMITTED A DELINQUENT ACT THAT CAUSED**
3 **THE A DEATH OR NEAR FATALITY ~~BEING REVIEWED BY THE LOCAL TEAM~~; AND**

4 (2) Access to all information and records maintained by any State or
5 local government agency, including birth certificates, law enforcement investigative
6 information, medical examiner investigative information, parole and probation
7 information and records, and information and records of a social services agency that
8 provided services to ~~the child or family~~:

9 **(I) A CHILD WHOSE DEATH IS BEING REVIEWED BY THE**
10 **LOCAL TEAM;**

11 **(II) A CHILD CONVICTED OF A CRIME OR ADJUDICATED AS**
12 **HAVING COMMITTED A DELINQUENT ACT THAT CAUSED A DEATH OR NEAR**
13 **FATALITY; OR**

14 **(III) THE FAMILY OF A CHILD DESCRIBED IN ITEM (I) OR (II)**
15 **OF THIS PARAGRAPH.**

16 5-708.

17 (a) Meetings of the State Team and of local teams shall be closed to the
18 public and not subject to Title 10, Subtitle 5 of the State Government Article when the
19 State Team or local teams are discussing individual cases of child deaths.

20 (b) Except as provided in subsection (c) of this section, meetings of the State
21 Team and of local teams shall be open to the public and subject to Title 10, Subtitle 5
22 of the State Government Article when the State Team or local team is not discussing
23 individual cases of child deaths.

24 (c) [(1) Information identifying a deceased child, a family member, a
25 guardian or caretaker of a deceased child, or an alleged or suspected perpetrator of
26 abuse or neglect upon a child, may not be disclosed during a public meeting.]

27 **(1) DURING A PUBLIC MEETING, INFORMATION MAY NOT BE**
28 **DISCLOSED THAT IDENTIFIES:**

29 **(I) A DECEASED CHILD;**

1 (II) A FAMILY MEMBER, GUARDIAN, OR CARETAKER OF A
2 DECEASED CHILD;

3 (III) AN ALLEGED OR SUSPECTED PERPETRATOR OF ABUSE
4 OR NEGLECT UPON A CHILD; OR

5 (IV) A CHILD CONVICTED OF A CRIME OR CONVICTED OF A
6 CRIME ADJUDICATED AS HAVING COMMITTED A DELINQUENT ACT THAT CAUSED
7 THE A DEATH OR NEAR FATALITY OF ANOTHER CHILD.

8 ~~(2) Information regarding the involvement of any agency with the~~
9 ~~deceased child or family may not be disclosed during a public meeting.~~

10 (2) DURING A PUBLIC MEETING, INFORMATION MAY NOT BE
11 DISCLOSED REGARDING THE INVOLVEMENT OF ANY AGENCY WITH:

12 (I) A DECEASED CHILD;

13 (II) A FAMILY MEMBER, GUARDIAN, OR CARETAKER OF A
14 DECEASED CHILD;

15 (III) AN ALLEGED OR SUSPECTED PERPETRATOR OF ABUSE
16 OR NEGLECT UPON A CHILD; OR

17 (IV) A CHILD CONVICTED OF A CRIME OR ADJUDICATED AS
18 HAVING COMMITTED A DELINQUENT ACT THAT CAUSED A DEATH OR NEAR
19 FATALITY.

20 (d) This section does not prohibit the State Team or a local team from
21 requesting the attendance at a team meeting of a person who has information relevant
22 to the team's exercise of its purpose and duties.

23 (e) Violation of this section is a misdemeanor and is punishable by a fine not
24 exceeding \$500 or imprisonment not exceeding 90 days or both.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2007.
