## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **The Baby Boomer Initiative Act**

3 FOR the purpose of establishing a Baby Boomer Initiative Council; establishing the  
4 membership of the Council; requiring the Governor to appoint the chair to the  
5 Council; establishing the duties of the Council; requiring the Council to make  
6 certain recommendations; providing for the staffing of the Council; requiring the  
7 Council to provide certain reports to the Governor and General Assembly on or  
8 before certain dates; providing for the termination of this Act; defining certain  
9 terms; and generally relating to the baby boomer population.

10 BY adding to

11 Article – Health – General

12 Section 24–1501 through 24–1505 to be under the new subtitle “Subtitle 15.

13 Baby Boomer Initiative Council”

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That the Laws of Maryland read as follows:

13   **ADDRESSING THE NEEDS OF THE BABY BOOMER POPULATION;**

14                   **(2) MAKE RECOMMENDATIONS REGARDING PUBLIC POLICY**  
15   **INITIATIVES FOR UTILIZING THE BABY BOOMER POPULATION AS A SOURCE OF**  
16   **SOCIAL CAPITAL AND AS A WAY TO ADDRESS COMMUNITY NEEDS;**

17                   **(3) MAKE RECOMMENDATIONS TO THE DEPARTMENT OF AGING**  
18   **FOR:**

19                           **(I) A MARKETING OUTREACH EFFORT TO BUSINESSES; AND**

20                           **(II) OUTREACH TO NONPROFIT ORGANIZATIONS, THE**  
21   **STATE DEPARTMENT OF EDUCATION, AND OTHER STATE AGENCIES;**

22                   **(4) MAKE RECOMMENDATIONS FOR ELIGIBLE CIVIC**  
23   **ENGAGEMENT AND MULTIGENERATIONAL ACTIVITIES SUCH AS EARLY**  
24   **CHILDHOOD EDUCATION AND AFTER-SCHOOL PROGRAMS, RESPITE SERVICES**  
25   **FOR OLDER ADULTS AND CAREGIVERS, AND TRANSITIONS FOR THE BABY**

1 **BOOMER POPULATION TO ENGAGE IN PURPOSEFUL WORK FOLLOWING THEIR**  
2 **EXIT FROM CAREER-TRACK WORK; AND**

3 **(5) STUDY AND DOCUMENT HEALTH AND SOCIAL BENEFITS**  
4 **DERIVED FROM:**

5 **(I) THE ACTIVE ENGAGEMENT OF THE BABY BOOMER**  
6 **POPULATION; AND**

7 **(II) INTERGENERATIONAL ACTIVITY, LIFE-LONG LEARNING,**  
8 **AND CIVIC ENGAGEMENT FOR THE GENERAL COMMUNITY.**

9 **(C) THE UNIVERSITY OF MARYLAND REPRESENTATIVE TO THE**  
10 **COUNCIL SHALL INITIATE A STUDY TO BETTER UNDERSTAND AND DOCUMENT:**

11 **(1) THE ECONOMIC IMPACT OF OLDER WORKERS' ROLES IN THE**  
12 **ECONOMY; AND**

13 **(2) THE SOCIAL IMPACT OF OLDER WORKERS' ROLES IN THE**  
14 **COMMUNITY.**

15 **(D) THE UNIVERSITY OF MARYLAND'S COLLEGE OF HEALTH AND**  
16 **HUMAN PERFORMANCE SHALL PROVIDE STAFF FOR THE COUNCIL.**

18 **ON OR BEFORE DECEMBER 31, 2008, AND ANNUALLY THEREAFTER, THE**  
19 **COUNCIL SHALL REPORT ITS FINDINGS AND RECOMMENDATIONS TO THE**  
20 **GOVERNOR AND, IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT**  
21 **ARTICLE, THE GENERAL ASSEMBLY.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
23 October 1, 2007. It shall remain effective for a period of 4 years and 3 months and, at  
24 the end of December 31, 2011, with no further action required by the General  
25 Assembly, this Act shall be abrogated and of no further force and effect.
