5 FOR the purpose of *designating a certain financial assistance program as the Delegate*
6 *Howard P. Rawlings Program of Educational Excellence Awards*; prohibiting
7 the Office of Student Financial Assistance from taking into consideration an
8 applicant's receipt of certain tax credits for purposes of determining eligibility
9 for ~~an Educational Excellence Award~~ *a Guaranteed Access Grant*; *requiring the*
10 *publishers of the Annotated Code of Maryland to correct certain terminology*
11 *rendered incorrect by this Act and to describe certain corrections in a certain*

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Education**

17 18–301.

18 (a) There is a **DELEGATE HOWARD P. RAWLINGS** Program of Educational
 19 Excellence Awards in this State that are awarded under this subtitle.

20 (b) The Program shall consist of the following types of awards:

21 (1) Guaranteed Access Grants that are awarded to the neediest
 22 students to ensure that 100 percent of educational costs, as defined by regulations
 23 adopted by the Commission, are paid; and

24 (2) Educational Assistance Grants that are awarded to low and
 25 moderate income students to assist in paying educational costs, as defined by
 26 regulations adopted by the Commission.

28 ~~(a) (1) Except as provided in subsection (d) of this section, the Office shall~~
 29 ~~compile and certify lists for the entire State that rank applicants by financial need.~~

1 ~~(2) TO DETERMINE THE FINANCIAL NEED OF AN APPLICANT, THE~~
2 ~~OFFICE MAY NOT CONSIDER AN AMOUNT RECEIVED BY THE APPLICANT AS AN~~

4 ~~(b) All funds for annual initial grants shall be awarded from the statewide~~

28 (a) Subject to subsection [(c)] **(D)** of this section, each recipient of ~~an~~ **A**
29 **DELEGATE HOWARD P. RAWLINGS** Educational Excellence Award shall:

1 (1) Be accepted for admission in the regular undergraduate program
2 at an eligible institution or be enrolled in a 2-year associate degree program in which
3 the course work is acceptable for transfer credit for an accredited baccalaureate
4 program in an eligible institution;

5 (2) Be a resident of this State;

6 (3) Demonstrate to the Office a definite financial need; and

7 (4) Accept any other conditions attached to the award.

8 (b) Each recipient of a Guaranteed Access Grant shall:

9 (1) Have attained a grade point average of at least 2.5 on a 4.0 scale or
10 its equivalent at the end of the first semester of the senior year in high school and
11 have completed high school or, failing to do so, on the recommendation of the
12 recipient's high school principal, provide evidence satisfactory to the Office of
13 extenuating circumstances;

14 (2) Begin college within 1 year of completing high school or, failing to
15 do so, provide evidence satisfactory to the Office of extenuating circumstances;

16 (3) Be under the age of 22 years at the time of receiving the first
17 award;

18 (4) Have successfully completed a college preparatory program in high
19 school;

20 (5) Enroll in college as a full-time student;

21 (6) **[Have] SUBJECT TO SUBSECTION (C) OF THIS SECTION, HAVE**
22 an annual family income below a poverty index determined by the Commission; and

23 (7) Satisfy any additional criteria the Commission may establish.

24 **(C) TO DETERMINE THE ANNUAL FAMILY INCOME ELIGIBILITY OF AN**
25 **APPLICANT FOR A GUARANTEED ACCESS GRANT, THE OFFICE MAY NOT**
26 **CONSIDER AN AMOUNT RECEIVED BY THE APPLICANT AS AN EARNED INCOME**
27 **CREDIT UNDER § 32 OF THE INTERNAL REVENUE CODE.**

28 **[(c)] (D)** A student in grade 9 or grade 10 who applies and qualifies for a
29 Guaranteed Access Grant on the basis of financial need as established by the

1 Commission shall prequalify for a Guaranteed Access Grant to be used at the time of
 2 enrollment in an institution of higher education by agreeing in writing, as a secondary
 3 and undergraduate student, to:

4 (1) Satisfy the attendance policy of the applicable school;

5 (2) Refrain from substance abuse;

6 (3) Provide information required by the Commission or the State
 7 Board of Education;

8 (4) Complete and file on a timely basis applications for federal student
 9 aid for each year that the student plans to enroll in postsecondary education;

10 (5) Participate in the College Readiness Outreach Program
 11 established in § 18-303.1 of this subtitle until the student graduates from high school
 12 and matriculates at an institution of higher education; and

13 (6) Satisfy any other program requirements set by the Office, the
 14 Commission, the State Board of Education, or the State Department of Education.

15 SECTION 2. AND BE IT FURTHER ENACTED, That the publisher of the
 16 Annotated Code of Maryland, in consultation with the Department of Legislative
 17 Services, shall correct, with no further action required by the General Assembly,
 18 terminology under Title 18, Subtitle 3 of the Education Article referring to the Program
 19 of Educational Excellence Awards rendered incorrect by this Act. The publisher shall
 20 adequately describe any such correction in an editor's note following an affected section.

21 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That this Act shall take
 22 effect July 1, 2007.
