- 1 (d) The service credit for military service that an individual receives under 2 this section shall be applied to the individual's retirement allowance using the accrual 3 rate in effect at the time the individual retires from a State system.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2007.
