A BILL ENTITLED

1 AN ACT concerning

2 **Northern Chesapeake Bay Crossing with Terminus in Kent County -**
3 **Prohibition on Planning, Financing, and Construction**

4 FOR the purpose of repealing certain authority of the State Roads Commission
5 concerning the construction and financing of a northern crossing of the
6 Chesapeake Bay between Millers Island in Baltimore County and Kent County;
7 prohibiting the Maryland Department of Transportation, the Maryland
8 Transportation Authority, or any unit in the Department, from including in
9 certain plans and other documents any reference or statement with respect to a
10 northern crossing of the Chesapeake Bay that has a terminus that lies in whole
11 or in part in Kent County; providing that a certain provision of this Act may not
12 be construed in a certain manner; providing that bonds or other financing
13 mechanisms authorized by law may not be used to finance the planning, design,
14 or construction of a northern crossing of the Chesapeake Bay that has a
15 terminus that lies in whole or in part in Kent County; requiring the
16 Department, the Authority, and any unit of the Department, if it is in
17 possession of any plan or other document prepared on or after a certain date,
18 that has a reference or statement with respect to a northern crossing of the
19 Chesapeake Bay that has a terminus that lies in whole or in part in Kent
20 County, to remove or cause the removal of that reference or statement from the
21 plan or document; amending a provision of law to prohibit the Authority from
22 condemning property in connection with the construction of a northern crossing
23 of the Chesapeake Bay that has a terminus that lies in whole or in part in Kent
24 County; and generally relating to prohibitions concerning a northern
25 Chesapeake Bay crossing that has a terminus in Kent County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Chapter 608 of the Acts of 1976**

22 SECTION 3. AND BE IT FURTHER ENACTED, That Sections 120 through
23 140, inclusive, of Article 89B – State Roads, of the Annotated Code of Maryland (1969
24 Replacement Volume and 1975 Supplement) be and they are hereby repealed and
25 reenacted, with amendments, and transferred from the Annotated Code of Maryland
26 to the Session Laws, to read as follows:

27 Bridge, Tunnel, and Motorway Revenue Bonds.

28 1.

29 (a) In order to remove the present handicaps and hazards on the congested
30 highways in the State, to facilitate vehicular traffic between different sections of the
31 State, to promote the agricultural and industrial development of the State, and to
32 provide for the construction of modern transportation facilities embodying practical
33 safety devices, the State Roads Commission is hereby authorized and empowered to
34 construct, maintain, repair and operate bridges, tunnels and motorways (as

1 hereinafter defined), including a crossing (as hereinafter defined) across the
2 Chesapeake Bay generally parallel to the existing Chesapeake Bay Bridge between
3 Sandy Point and Kent Island, [a northern crossing of the bay between Millers Island
4 in Baltimore County and a point in Kent County,] a southern crossing of the bay
5 between Calvert County and Dorchester County, and an additional crossing across the
6 Baltimore Harbor, and to issue revenue bonds of the State, payable solely from
7 revenues, to pay the cost of such projects. [Such commission] **EXCEPT FOR A**
8 **NORTHERN CROSSING OF THE CHESAPEAKE BAY THAT HAS A TERMINUS THAT**
9 **LIES IN WHOLE OR IN PART WITHIN THE BOUNDARIES OF KENT COUNTY, THE**
10 **COMMISSION** is authorized to establish construction priorities and determine the
11 order of the construction of such projects.

12 (b) In order to establish the location of such crossings and their approaches
13 thereby permitting orderly land development and to permit the acquisition of
14 necessary rights-of-way for such projects at the minimum cost to the State, the State
15 Roads Commission is hereby authorized to perform or have performed preliminary
16 engineering for a crossing of the bay generally parallel to the existing Chesapeake Bay
17 Bridge, [a crossing of the bay between Millers Island in Baltimore County and a point
18 in Kent County,] a crossing of the bay between Calvert County and Dorchester
19 County, and a second crossing across the Baltimore Harbor and the approaches
20 thereto of each of such crossings. [The] **EXCEPT FOR A NORTHERN CROSSING OF**
21 **THE CHESAPEAKE BAY THAT HAS A TERMINUS THAT LIES IN WHOLE OR IN PART**
22 **WITHIN THE BOUNDARIES OF KENT COUNTY, THE** Commission is further
23 authorized to perform or have performed such engineering and other services as are
24 necessary to enable it to acquire the right-of-way for such projects and is authorized
25 to acquire such right-of-way. [In] **EXCEPT FOR A NORTHERN CROSSING OF THE**
26 **CHESAPEAKE BAY THAT HAS A TERMINUS THAT LIES IN WHOLE OR IN PART**
27 **WITHIN THE BOUNDARIES OF KENT COUNTY, IN** order to pay the cost of such
28 engineering and other services and to pay the cost of such right-of-way the
29 Commission is authorized to issue revenue bonds as authorized in § 1(a) hereof, or the
30 Commission may pay such costs, or parts thereof, from its Construction Fund or other
31 appropriate funds and be reimbursed therefor upon the sale of such revenue bonds. As
32 to contracts which are not let by competitive bidding procedures, the State Roads
33 Commission shall not make any contract for engineering, architectural, or
34 construction studies or work under the provisions of this section without the prior
35 approval of the Board of Public Works.

1 (A) (1) THIS SUBSECTION SHALL APPLY NOTWITHSTANDING ANY
2 PROVISION OF TITLE 3 OR TITLE 4 OF THIS ARTICLE OR ANY OTHER LAW TO
3 THE CONTRARY.

4 (2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH,
5 THE DEPARTMENT, INCLUDING ANY UNIT OF THE DEPARTMENT AND THE
6 MARYLAND TRANSPORTATION AUTHORITY, MAY NOT INCLUDE IN THE
7 MARYLAND TRANSPORTATION PLAN, THE CONSOLIDATED TRANSPORTATION
8 PROGRAM, OR ANY OTHER PLAN, STUDY, ANALYSIS, REPORT, PROPOSAL,
9 CONCEPTUALIZATION, OR OTHER DOCUMENT, A REFERENCE OR STATEMENT
10 WITH RESPECT TO A POSSIBLE NORTHERN CHESAPEAKE BAY CROSSING THAT
11 HAS A TERMINUS THAT LIES IN WHOLE OR IN PART WITHIN THE BOUNDARIES OF
12 KENT COUNTY.

13 (II) SUBPARAGRAPH (I) OF THIS PARAGRAPH MAY NOT BE
14 CONSTRUED:

15 1. TO PRECLUDE THE DEPARTMENT, INCLUDING
16 ANY UNIT OF THE DEPARTMENT, OR THE MARYLAND TRANSPORTATION
17 AUTHORITY FROM INCLUDING IN THE MARYLAND TRANSPORTATION PLAN,
18 THE CONSOLIDATED TRANSPORTATION PROGRAM, OR ANY OTHER PLAN,
19 STUDY, ANALYSIS, REPORT, CONCEPTUALIZATION, OR OTHER DOCUMENT A
20 STATEMENT THAT PROHIBITS THE PLANNING, DESIGN, OR CONSTRUCTION OF A
21 NORTHERN CHESAPEAKE BAY CROSSING THAT HAS A TERMINUS THAT LIES IN
22 WHOLE OR IN PART WITHIN THE BOUNDARIES OF KENT COUNTY; OR

23 2. TO PRECLUDE KENT COUNTY FROM INCLUDING
24 IN ITS COMPREHENSIVE PLAN FOR THE COUNTY A STATEMENT THAT PROHIBITS
25 THE PLANNING, DESIGN, OR CONSTRUCTION OF A NORTHERN CHESAPEAKE BAY
26 CROSSING THAT HAS A TERMINUS THAT LIES IN WHOLE OR IN PART WITHIN THE
27 BOUNDARIES OF KENT COUNTY.

28 (3) BONDS OR FUNDING MECHANISMS OF ANY NATURE
29 AUTHORIZED UNDER THIS ARTICLE OR ANY OTHER LAW WITH RESPECT TO THE
30 FINANCING OF THE PLANNING, DESIGN, OR CONSTRUCTION OF ANY
31 TRANSPORTATION FACILITY OR TRANSPORTATION FACILITIES PROJECT MAY
32 NOT BE USED TO FINANCE THE PLANNING, DESIGN, OR CONSTRUCTION OF A
33 NORTHERN CHESAPEAKE BAY CROSSING THAT HAS A TERMINUS THAT LIES IN
34 WHOLE OR IN PART WITHIN THE BOUNDARIES OF KENT COUNTY.

1 **(B) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, IF, ON OR**
2 **AFTER JUNE 1, 2007, ANY PLAN, STUDY, ANALYSIS, REPORT, PROPOSAL,**
3 **CONCEPTUALIZATION, OR OTHER DOCUMENT CONTAINS A REFERENCE OR**
4 **STATEMENT IN VIOLATION OF SUBSECTION (A)(2)(I) OF THIS SECTION, THE**
5 **DEPARTMENT, INCLUDING ANY UNIT OF THE DEPARTMENT, OR THE MARYLAND**
6 **TRANSPORTATION AUTHORITY, AS APPROPRIATE, SHALL REMOVE OR CAUSE**
7 **THE REMOVAL OF THE REFERENCE OR STATEMENT.**

8 **(2) PARAGRAPH (1) OF THIS SUBSECTION APPLIES TO ANY**
9 **DOCUMENT IN THE POSSESSION OF THE DEPARTMENT, INCLUDING ANY UNIT OF**
10 **THE DEPARTMENT, OR THE MARYLAND TRANSPORTATION AUTHORITY,**
11 **WHETHER OR NOT:**

12 **(I) THE DOCUMENT ORIGINATED IN THE DEPARTMENT; OR**

13 **(II) THE DOCUMENT IS IN PRINTED, ELECTRONIC, OR**
14 **OTHER FORMAT.**

16 Subject to Title 12 of the Real Property Article and Ch. 608, Acts of 1976, **AS**
17 **AMENDED BY CHAPTER _____ (S.B._____/H.B._____) (7LR0741) OF THE ACTS OF**
18 **THE GENERAL ASSEMBLY OF 2007, AND EXCEPT FOR A NORTHERN CROSSING**
19 **OF THE CHESAPEAKE BAY THAT HAS A TERMINUS THAT LIES IN WHOLE OR IN**
20 **PART WITHIN THE BOUNDARIES OF KENT COUNTY,** the Authority may condemn
21 property for any transportation facilities project authorized to be financed with
22 revenue bonds of prior issues.

25 (a) A State agency, including the Maryland Transportation Authority, may
26 not construct any toll road, toll highway, or toll bridge in the counties enumerated in
27 this section without the express consent of a majority of the governments of the
28 affected counties.

29 (b) This section applies to:

30 (1) Caroline County;

- 1 (2) Cecil County;
- 2 (3) Dorchester County;
- 3 (4) Kent County;
- 4 (5) Queen Anne's County;
- 5 (6) Somerset County;
- 6 (7) Talbot County;
- 7 (8) Wicomico County; and
- 8 (9) Worcester County.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 June 1, 2007.
