AMENDMENTS TO HOUSE BILL 393

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “repealing” in line 3 down through “discoverable” in line 7 and substitute “requiring certain individuals to submit a certain report to a certain health officer under certain circumstances; requiring certain reports to contain certain information, be in a certain format, and be transmitted in a certain manner; providing that certain provisions of this Act do not apply to or restrict the use of certain statistics, information, or other material”; and strike beginning with “providing” in line 17 down through “discoverable” in line 20 and substitute “requiring the Secretary to adopt certain regulations”.

AMENDMENT NO. 2

On page 2, in line 6, after “has” insert “**A CONDITION OR**”; in the same line, after “disease” insert a comma; in line 7, after “syndrome” insert a comma; in the same line, after “health” insert “**AND THAT HAS BEEN DESIGNATED BY THE SECRETARY AS REPORTABLE**”; in line 10, strike the opening bracket; after line 10, insert:

**“(1) CONTAIN THE INFORMATION AND BE IN A FORMAT SPECIFIED OR APPROVED BY THE SECRETARY; AND**

**(2) BE TRANSMITTED AS DIRECTED BY THE SECRETARY.”;**

strike in their entirety lines 11 through 15; and strike beginning with the closing bracket in line 20 down through “**MATTER.**” in line 30, inclusive.

AMENDMENT NO. 3

(Over)

On page 3, in line 1, strike “(3)” and substitute “(2)”; in line 2, strike “GENERALLY” and substitute “NONINDIVIDUALLY”; in the same line, after “CASES” insert “OF A CONDITION OR DISEASE”; after line 5, insert:

**“(3) THIS SUBSECTION DOES NOT APPLY TO OR RESTRICT THE USE OR PUBLICATION OF ANY STATISTICS, INFORMATION, OR OTHER MATERIAL THAT SUMMARIZES OR REFERS TO CONFIDENTIAL RECORDS IN THE AGGREGATE, WITHOUT DISCLOSING THE IDENTITY OF ANY INDIVIDUAL WHO IS THE SUBJECT OF THE CONFIDENTIAL RECORD.”;**

strike in their entirety lines 14 through 22, inclusive; in line 28, after “has” insert “A CONDITION OR”; in the same line, after “disease” insert a comma; in line 29, after “syndrome” insert “, THAT HAS BEEN DESIGNATED BY THE SECRETARY AS REPORTABLE”; in line 32, strike the opening bracket; and after line 32, insert:

**“(1) CONTAIN THE INFORMATION AND BE IN A FORMAT SPECIFIED OR APPROVED BY THE SECRETARY; AND**

**“(2) BE TRANSMITTED AS DIRECTED BY THE SECRETARY.”.**

AMENDMENT NO. 4

On page 4, strike in their entirety lines 1 through 5, inclusive; strike beginning with the closing bracket in line 10 down through “MATTER.” in line 20; after line 20 insert:

**“(2) THIS SUBSECTION DOES NOT APPLY TO OR RESTRICT THE USE OR PUBLICATION OF ANY STATISTICS, INFORMATION, OR OTHER MATERIAL THAT SUMMARIZES OR REFERS TO CONFIDENTIAL RECORDS IN THE AGGREGATE, WITHOUT DISCLOSING THE IDENTITY OF ANY INDIVIDUAL WHO IS THE SUBJECT OF THE CONFIDENTIAL RECORD.”;**

in line 22, strike “**GENERALLY**” and substitute “**NONINDIVIDUALLY**”; and in the same line, after “**CASES**” insert “**OF A CONDITION OR A DISEASE**”.

AMENDMENT NO. 5

On page 5, strike in their entirety lines 3 through 11, inclusive; in line 25, strike “**NUCLEIC ACID**” and substitute “**MICROBIAL GENETIC MATERIAL**”; in line 13, strike the opening bracket; strike beginning with the closing bracket in line 13 down through “**(1)**” in line 15; in lines 16, 17, and 20, strike “**(I)**”, “**(II)**”, and “**(III)**”, respectively, and substitute “**(1)**”, “**(2)**”, and “**(3)**”, respectively; in lines 24, 25, and 26, strike “**1.**”, “**2.**”, and “**3.**”, respectively, and substitute “**(I)**”, “**(II)**”, and “**(III)**”, respectively; and strike in their entirety lines 27 and 28.

AMENDMENT NO. 6

On page 9, after line 18, insert:

**“(1) CONTAIN THE INFORMATION AND BE IN A FORMAT SPECIFIED OR APPROVED BY THE SECRETARY; AND**

**“(2) BE TRANSMITTED AS DIRECTED BY THE SECRETARY.”;**

and strike in their entirety lines 19 through 28, inclusive.

AMENDMENT NO. 7

On page 10, in line 16, strike the opening bracket; in line 28, strike the closing bracket; and strike in their entirety lines 29 through 32, inclusive.

AMENDMENT NO. 8

On page 11, strike in their entirety lines 1 through 5, inclusive; in line 6, strike “**(3)**” and substitute “**(4)**”; in line 7, strike “**GENERALLY**” and substitute “**NONINDIVIDUALLY**”; in the same line, after “**CASES**” insert “**OF A CONDITION OR A**”.

(Over)

DISEASE"; in line 11, strike "(4)" and substitute "**(5)**"; and strike in their entirety lines 19 through 27, inclusive, and substitute:

**"(6) THIS SUBSECTION DOES NOT APPLY TO OR RESTRICT THE USE OR PUBLICATION OF ANY STATISTICS, INFORMATION, OR OTHER MATERIAL THAT SUMMARIZES OR REFERS TO CONFIDENTIAL RECORDS IN THE AGGREGATE, WITHOUT DISCLOSING THE IDENTITY OF ANY INDIVIDUAL WHO IS THE SUBJECT OF THE CONFIDENTIAL RECORD."**

AMENDMENT NO. 9

On page 11, after line 30, insert:

**"(J) THE SECRETARY SHALL ADOPT REGULATIONS THAT DESIGNATE THE DISEASES OR CONDITIONS THAT ARE REPORTABLE BY A DIRECTOR OF A MEDICAL LABORATORY UNDER THIS SECTION."**
