BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 13 14 **Article - State Personnel and Pensions** 15 38-104.This section applies to an individual who is: 16 (a) (1) (i) a member of a State system; or 17 18 a former member of a State system who is eligible to receive 19 a benefit under § 29–302 or § 29–303 of this article.
