CHAPTER _____

1 AN ACT concerning

2 **Department of Juvenile Services – Youth Welfare Funds**

3 FOR the purpose of establishing youth welfare funds in Department of Juvenile
4 Services facilities; providing for the contents and uses of youth welfare funds;
5 requiring the Comptroller to account for and distribute youth welfare funds
6 under certain circumstances; prohibiting certain money from being transferred
7 into a fund; providing that a fund is subject to an audit under certain
8 circumstances; defining a certain term; and generally relating to youth welfare
9 funds.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Human Services**

18 **9–246.**

19 (A) **IN THIS SECTION, “FUND” MEANS A YOUTH WELFARE FUND.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 **(B) (1) THERE IS A YOUTH WELFARE FUND IN EACH FACILITY OF THE**
2 **DEPARTMENT OF JUVENILE SERVICES.**

3 **(2) A FUND SHALL BE USED FOR GOODS AND SERVICES THAT**
4 **BENEFIT THE GENERAL YOUTH POPULATION IN THE FACILITY.**

5 **(C) (1) EACH FUND IS A SPECIAL CONTINUING, NONLAPSING FUND**
6 **THAT IS NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT**
7 **ARTICLE.**

8 **(2) EACH FUND CONSISTS OF:**

9 **(I) PROFITS DERIVED FROM THE SALE OF GOODS THROUGH**
10 **THE COMMISSARY OPERATION AND TELEPHONE AND VENDING MACHINE**
11 **COMMISSIONS FOR THE FACILITY; AND**

12 **(II) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION,**
13 **MONEY RECEIVED FROM OTHER SOURCES.**

14 **(3) MONEY FROM THE GENERAL FUND OF THE STATE MAY NOT**
15 **BE TRANSFERRED BY BUDGET AMENDMENT OR OTHER MANNER TO A FUND.**

16 **(D) (1) THE TREASURER SHALL HOLD EACH FUND SEPARATELY, AND**
17 **THE COMPTROLLER SHALL ACCOUNT FOR EACH FUND.**

18 **(2) EACH FUND IS SUBJECT TO AN AUDIT BY THE OFFICE OF**
19 **LEGISLATIVE AUDITS UNDER § 2-1220 OF THE STATE GOVERNMENT ARTICLE.**

20 **(3) (I) EACH FUND SHALL BE INVESTED AND REINVESTED IN**
21 **THE SAME MANNER AS OTHER STATE FUNDS.**

22 **(II) ANY INVESTMENT EARNINGS ARE NOT A PART OF THE**
23 **FUND.**

24 **(E) THE COMPTROLLER SHALL PAY OUT MONEY FROM EACH FUND AS**
25 **APPROPRIATED IN THE STATE BUDGET.**

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 June 1, 2008.
