AMENDMENTS TO HOUSE BILL 296, AS AMENDED  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, in line 2, after “Firearms” insert “and Reporting”; and in line 6, before “making” insert “requiring the Governor’s Office of Crime Control and Prevention to compile a certain report which includes certain statistical information, to submit the report to the Governor and General Assembly on or before a certain date each year, and to make the report available to the public upon request;”.

On page 1 of the House Judiciary Committee Amendments (HB0296/922317/1), in line 10 of Amendment No. 1, after “4-506.1” insert “and 4-506.2”.

AMENDMENT NO. 2

On page 5 of the bill, before line 30, insert:

**“4-506.2.**

**(A) IN THIS SECTION, “OFFICE” MEANS THE GOVERNOR’S OFFICE OF CRIME CONTROL AND PREVENTION.**

**(B) THE OFFICE SHALL COMPILE AN ANNUAL REPORT THAT INCLUDES THE NUMBER OF TEMPORARY PROTECTIVE ORDERS THAT RESULT IN A FINAL PROTECTIVE ORDER AND, WITH REGARD TO TEMPORARY AND FINAL PROTECTIVE ORDERS, INCLUDES:**

**(1) THE NUMBER OF ORDERS SOUGHT, BROKEN DOWN BY GENDER OF THE PERSON SEEKING THE ORDER;**

(Over)

**(2) THE NUMBER OF ORDERS GRANTED, BROKEN DOWN BY GENDER OF THE PERSON SEEKING THE ORDER;**

**(3) A BREAKDOWN OF REASONS WHY THE ORDER WAS SOUGHT, BROKEN DOWN BY GENDER OF THE PERSON SEEKING THE ORDER;**

**(4) THE NUMBER OF ORDERS VACATED, DISMISSED, OR WITHDRAWN PRIOR TO A FINAL HEARING;**

**(5) THE NUMBER OF ORDERS IGNORED OR VIOLATED BY THE RESPONDENT DURING THE TERM OF THE ORDER;**

**(6) THE NUMBER OF ASSAULTS COMMITTED BY THE RESPONDENT DURING THE TERM OF THE ORDER, BROKEN DOWN BY TYPE, WEAPON INVOLVED, AND THE AGE AND GENDER OF THE VICTIM;**

**(7) THE NUMBER OF HOMICIDES COMMITTED BY THE RESPONDENT DURING THE TERM OF THE ORDER, BROKEN DOWN BY TYPE, WEAPON INVOLVED, AND THE AGE AND GENDER OF THE VICTIM;**

**(8) THE NUMBER OF HOMICIDES COMMITTED BY THE RESPONDENT AFTER THE EXPIRATION OF THE ORDER, BROKEN DOWN BY TYPE, WEAPON INVOLVED, AND THE AGE AND GENDER OF THE VICTIM;**

**(9) THE NUMBER OF INCIDENTS WHERE LAW ENFORCEMENT AUTHORITIES CONFISCATED A FIREARM WITHOUT SPECIFIC AUTHORIZATION FROM THE COURTS; AND**

**(10) THE NUMBER OF INCIDENTS OF VIOLENCE THAT OCCURRED AFTER LAW ENFORCEMENT AUTHORITIES CONFISCATED A FIREARM.**

**(C) ON OR BEFORE DECEMBER 31 OF EACH YEAR, THE OFFICE SHALL SUBMIT THE REPORT COMPILED UNDER SUBSECTION (B) OF THIS SECTION TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, TO THE GENERAL ASSEMBLY.**

**(D) THE OFFICE SHALL MAKE THE REPORT COMPILED UNDER SUBSECTION (B) OF THIS SECTION AVAILABLE TO THE PUBLIC ON REQUEST.”.**
