On page 2, after line 27, insert:

"(II) 1. BEFORE THE DATE OF THE MEETING HELD UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE DEVELOPER SHALL DELIVER TO EACH UNIT OWNER NOTICE THAT THE REQUIREMENTS OF SUBPARAGRAPH (I) OF THIS PARAGRAPH HAVE BEEN MET.

2. <u>THE NOTICE SHALL INCLUDE THE DATE, TIME,</u> <u>AND PLACE OF THE MEETING TO ELECT THE BOARD OF DIRECTORS FOR THE</u> <u>COUNCIL OF UNIT OWNERS.</u>";

and in lines 28 and 32, strike "(II)" and "(III)", respectively, and substitute "(III)" and "(IV)", respectively.

On page 3, in lines 9 and 24, strike "(IV)" and "(V)", respectively, and substitute "(V)" and "(VI)", respectively.

On page 6, after line 12, insert:

"(B) (1) BEFORE THE DATE OF THE MEETING HELD UNDER SUBSECTION (A) OF THIS SECTION, THE DECLARANT SHALL DELIVER TO EACH LOT OWNER NOTICE THAT THE REQUIREMENTS OF SUBSECTION (A) OF THIS SECTION HAVE BEEN MET.

(2) <u>THE NOTICE SHALL INCLUDE THE DATE, TIME, AND PLACE OF</u> <u>THE MEETING TO ELECT THE GOVERNING BODY OF THE HOMEOWNERS</u> <u>ASSOCIATION.</u>";

On page 7, in line 28, strike "(D)" and substitute "(E)".

On page 8, in line 10, strike "(E)" and substitute "(F)".

On page 3 in line 3 and on page 7 in line 19, in each instance, after "FUNDS" insert ", INCLUDING OPERATING FUNDS, REPLACEMENT RESERVES, INVESTMENT ACCOUNTS, AND WORKING CAPITAL".

On page 3 in line 13 and on page 7 in line 32, in each instance, strike "**OF**" and substitute "**FOR**".
