AMENDMENTS TO SENATE BILL 277  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Statewide Authorization and”; strike beginning with “expanding” in line 4 down through “program;” in line 26; strike beginning with the first “the” in line 28 down through “the” in line 29; and in line 29, after “from” insert “certain”.

On pages 1 and 2, strike beginning with “in” in line 30 on page 1 down through “system” in line 1 on page 2 and substitute “to be distributed to a certain special fund to be used only for certain purposes”.

On pages 2 and 3, strike beginning with “repealing” in line 45 on page 2 down through a “date;” in line 7 on page 3 and substitute “providing for a delayed effective date for certain provision of this Act;”.

On page 3, in line 27, strike “21–809;”; in line 32, after “Section” insert “12–118(e) and”; and after line 34, insert:

“BY repealing and reenacting, with amendments,

Article - Transportation

Section 12-118(e)

Annotated Code of Maryland

(2006 Replacement Volume and 2008 Supplement)

(As enacted by Section 1 of this Act)”.

AMENDMENT NO. 2

On pages 3 through 13, strike in their entirety the lines beginning with line 37 on page 3 down through line 17 on page 13.

(Over)

On page 26, strike in their entirety lines 5 through 20, inclusive.

AMENDMENT NO. 3

On page 16, strike beginning with “TO” in line 15 down through “ADMINISTRATION” in line 16; strike beginning with “IN” in line 18 down through “SYSTEM” in line 19 and substitute “TO A SPECIAL FUND, TO BE USED ONLY AS PROVIDED IN SUBSECTION (E) OF THIS SECTION”; and after line 19, insert:

“(E) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, MONEY IN THE SPECIAL FUND ESTABLISHED UNDER SUBSECTION (C)(2) OF THIS SECTION SHALL BE DISTRIBUTED TO THE DEPARTMENT OF STATE POLICE AND THE STATE HIGHWAY ADMINISTRATION TO COVER THE COSTS OF IMPLEMENTING AND ADMINISTERING WORK ZONE SPEED CONTROL SYSTEMS.

“(2) THE BALANCE OF THE MONEY IN THE SPECIAL FUND SHALL BE DISTRIBUTED TO THE DEPARTMENT OF STATE POLICE TO FUND ROADSIDE ENFORCEMENT ACTIVITIES.”.

AMENDMENT NO. 4

On page 25, after line 36, insert:

“SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

Article – Transportation

12–118.

(e) (1) Subject to paragraph (2) of this subsection, money in the special fund established under subsection (c)(2) of this section shall be distributed to the

Department of State Police and the State Highway Administration to cover the costs of implementing and administering work zone speed control systems.

(2) The balance of the money in the special fund shall be distributed to the [Department of State Police to fund roadside enforcement activities]**TRANSPORTATION TRUST FUND ESTABLISHED UNDER § 3-216 OF THIS ARTICLE.**

On page 26, after line 20, insert:

“SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take effect October 1, 2012.”;

in line 21, strike “8.” and substitute “5.”; and in the same line, after “That” insert “, except as provided in Section 4 of this Act.”.
