Family Law - Temporary Protective Orders - Surrender of Firearms

- 3 FOR the purpose of authorizing a judge in entering a temporary protective order to 4 order a certain person to surrender to law enforcement authorities any firearm 5 in the person's possession and to refrain from possessing any firearm for a certain period of time under certain circumstances; requiring a law enforcement 6 7 officer to provide certain information to a respondent when a firearm is surrendered and to provide for the safe storage of the firearm transport and 8 9 store the firearm in a certain manner; providing for the retaking of surrendered firearms by the respondent except under certain circumstances; making it a 10 misdemeanor subject to certain penalties to fail to comply with a certain order 11 to surrender firearms; and generally relating to protective orders and surrender 12 13 of firearms.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF 3 MARYLAND, That the Laws of Maryland read as follows: 4 **Article - Family Law** 5 4-505.6 If, after a hearing on a petition, whether ex parte or otherwise, a (a) (1) 7 judge finds that there are reasonable grounds to believe that a person eligible for relief 8 has been abused, the judge may enter a temporary protective order to protect any 9 person eligible for relief from abuse. 10 The temporary protective order may order any or all of the 11 following relief: 12 order the respondent to refrain from further abuse or threats (i) of abuse of a person eligible for relief; 13 14 order the respondent to refrain from contacting, attempting (ii) 15 to contact, or harassing any person eligible for relief; 16 order the respondent to refrain from entering the residence 17 of a person eligible for relief; 18 where the person eligible for relief and the respondent are (iv) 19 residing together at the time of the alleged abuse, order the respondent to vacate the home immediately and award temporary use and possession of the home to the person 20eligible for relief or in the case of alleged abuse of a child or alleged abuse of a 21 vulnerable adult, award temporary use and possession of the home to an adult living 22 in the home, provided that the court may not grant an order to vacate and award 23temporary use and possession of the home to a nonspouse person eligible for relief 24 25 unless the name of the person eligible for relief appears on the lease or deed to the home or the person eligible for relief has resided in the home with the respondent for a 26 27 period of at least 90 days within 1 year before the filing of the petition: 28 order the respondent to remain away from the place of 29 employment, school, or temporary residence of a person eligible for relief or home of other family members; 30 31 (vi) order the respondent to remain away from a child care 32 provider of a person eligible for relief while a child of the person is in the care of the 33 child care provider; [and]
