11 (b) (1) “Advertise falsely” means to use any advertisement, including a
 12 label, which is misleading in a material respect.

13 (2) “Advertise falsely” includes the use of an advertisement that
 14 contains an affirmative representation that the Maryland ~~Sales and Use Tax~~ sales and
 15 use tax will not be collected by the retailer on a particular transaction without
 16 notifying the purchaser of the purchaser’s duty to pay the sales and use tax directly to
 17 the Comptroller of this State.

18 (c) “Person” includes an individual, corporation, business trust, estate, trust,
 19 partnership, association, two or more persons having a joint or common interest, or
 20 any other legal or commercial entity.

21 (D) “TELEPHONE COMPANY” HAS THE MEANING STATED IN § 1-101 OF
 22 THE PUBLIC UTILITY COMPANIES ARTICLE.

25 (a) Any person who violates any provision of this subtitle is subject to a
26 penalty not exceeding \$500 for each violation, which penalty the Attorney General
27 may recover for the State in a civil action.

28 (b) Before the Attorney General commences any action under this section, he
29 shall give to the person against whom the action is proposed:

30 (1) Notice by registered or certified mail of the proposed action; and

31 (2) An opportunity to show cause orally or in writing why the action
32 should not be commenced.

2 October 1, 2009.
