A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Offender Registry – Retroactivity**

3 FOR the purpose of providing that certain provisions requiring the registration on a
4 certain offender registry of certain persons convicted of committing certain
5 offenses are to be applied retroactively to include a person convicted on or after
6 a certain date of an offense committed before a certain date; and generally
7 relating to the offender registry.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

22 (a) Notwithstanding any other provision of law to the contrary, except as
23 provided in subsection (b) of this section, this subtitle shall be applied retroactively to

1 include a registrant convicted of an offense committed before July 1, 1997, and who is
2 under the custody or supervision of a supervising authority on October 1, 2001.

3 (b) Notwithstanding any other provision of law to the contrary, this subtitle
4 shall be applied retroactively to a child sexual offender who committed the sexual
5 offense on or before October 1, 1995, and who is under the custody or supervision of a
6 supervising authority on October 1, 2001.

7 (C) **NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE**
8 **CONTRARY, THIS SUBTITLE SHALL BE APPLIED RETROACTIVELY TO INCLUDE A**
9 **PERSON CONVICTED ON OR AFTER OCTOBER 1, 1995, OF ONE OF THE**
10 **FOLLOWING OFFENSES COMMITTED BEFORE OCTOBER 1, 1995:**

11 (1) **RAPE IN THE FIRST DEGREE UNDER § 3-303 OF THE**
12 **CRIMINAL LAW ARTICLE;**

13 (2) **RAPE IN THE SECOND DEGREE UNDER § 3-304(A)(1) OR (2) OF**
14 **THE CRIMINAL LAW ARTICLE;**

15 (3) **SEXUAL OFFENSE IN THE FIRST DEGREE UNDER § 3-305 OF**
16 **THE CRIMINAL LAW ARTICLE;**

17 (4) **SEXUAL OFFENSE IN THE SECOND DEGREE UNDER §**
18 **3-306(A)(1) OR (2) OF THE CRIMINAL LAW ARTICLE; OR**

19 (5) **SEXUAL ABUSE OF A MINOR UNDER § 3-602 OF THE CRIMINAL**
20 **LAW ARTICLE.**

22 (a) A person shall register with the person's supervising authority if the
23 person is:

24 (1) a child sexual offender;

25 (2) an offender;

26 (3) a sexually violent offender;

27 (4) a sexually violent predator;

28 (5) a child sexual offender who, before moving into this State, was
29 required to register in another state or by a federal, military, or Native American
30 tribal court for a crime that occurred before October 1, 1995;

1 (6) an offender, sexually violent offender, or sexually violent predator
2 who, before moving into this State, was required to register in another state or by a
3 federal, military, or Native American tribal court for a crime that occurred before July
4 1, 1997; or

5 (7) a child sexual offender, offender, sexually violent offender, or
6 sexually violent predator who is required to register in another state, who is not a
7 resident of this State, and who enters this State:

8 (i) to carry on employment;

9 (ii) to attend a public or private educational institution,
10 including a secondary school, trade or professional institution, or institution of higher
11 education, as a full-time or part-time student; or

12 (iii) as a transient.

13 (b) Notwithstanding any other provision of law, a person is no longer subject
14 to registration under this subtitle if:

15 (1) the underlying conviction requiring registration is reversed,
16 vacated, or set aside; or

17 (2) the registrant is pardoned for the underlying conviction.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2009.
