## A BILL ENTITLED

2 **Maryland Consolidated Capital Bond Loans of 2002, 2003, 2004, and 2007**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2002,  
5 2003, 2004, and 2007 to alter the purpose and project location of certain grants  
6 to the Board of Directors of Victory Youth Centers, Inc.; and generally relating  
7 to altering certain grants to the Board of Directors of Victory Youth Centers,  
8 Inc.

 5 **RENOVATION,** and capital equipping of [a multi-purpose  
 6 youth facility] **THE VICTORY YOUTH CENTER FACILITY,**
