### AMENDMENT NO. 1

On page 4, in line 14, strike "PROVIDES" and substitute "IF DENIED, PROVIDES".

## AMENDMENT NO. 2

On page 4, in line 24, after "NONPROFIT" insert "AND GOVERNMENTAL".

On page 7, in line 25, strike "STATE".

### AMENDMENT NO. 3

On page 5, in line 17, strike "OF THE UNITS" and substitute "UNIT".

# AMENDMENT NO. 4

On page 9, in line 5, after "<u>ANALYSIS</u>" insert "<u>ON BEHALF OF THE SECURED</u> PARTY".

On page 19, in line 6, after "<u>WITH</u>" insert "<u>YOU</u>,"; in the same line, after "<u>LENDER</u>" insert a comma; and in line 11, before "<u>FORECLOSURE</u>" insert "LENDER'S".

On page 20, in line 18, strike "FOR" and substitute "ONLY FOR".

On page 22, in line 25, after the second "THE" insert "SECURED PARTY'S".

### AMENDMENT NO. 5

#### JPR

On page 23, in line 15, strike "<u>FORWARD</u>" and substitute "<u>TRANSMIT</u>"; in line 17, after "<u>(1)</u>"; in the same line, strike "<u>RECEIPT</u>" and substitute "<u>TRANSMITTAL</u>"; and after line 19, insert:

"(II) FOR GOOD CAUSE, THE OFFICE OF ADMINISTRATIVE HEARINGS MAY EXTEND THE TIME FOR COMPLETING THE FORECLOSURE MEDIATION FOR A PERIOD NOT EXCEEDING 30 DAYS.".

On page 24, in line 14, after "<u>MEDIATION</u>" insert "<u>WITHIN THE EARLIER OF</u>"; in line 15, strike "<u>WITHIN</u>"; and in line 17, strike "<u>AT THE</u>" and substitute "<u>THE</u>".

#### AMENDMENT NO. 6

On page 27, in lines 15 and 24, in each instance, after "<u>HOMEOWNERS</u>" insert "<u>OR OCCUPANTS</u>"; and in line 24, after "<u>DIFFICULTY</u>" insert "<u>OR FORECLOSURE</u>".

#### AMENDMENT NO. 7

On page 29, after line 1, insert:

"(3) Notice accompanying order to docket or complaint to foreclose;";

in lines 2 and 3, strike "(3)" and "(4)", respectively, and substitute "(4)" and "(5)", respectively; in line 10, strike "exacted" and substitute "enacted"; in the same line, strike "and"; after line 10, insert:

"(2) the notice accompanying the order to docket or complaint to foreclose required under § 7–105.1(d)(ix) of the Real Property Article, as enacted by Section 1 of this Act, shall be deemed in compliance with § 7–105.1(d)(ix) of the Real Property Article, as enacted by Section 1 of this Act, if the language in the notice is substantially similar to the language in that section; and";

and in line 11, strike "(2)" and substitute "(3)".
