AMENDMENTS TO SENATE BILL 865  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “granting” in line 12 down through “policies;” in line 14; and strike beginning with “providing” in line 16 down through “damages” in line 17 and substitute “defining certain terms”.

AMENDMENT NO. 2

On page 2, strike beginning with “HEAD” in line 22 down through “SKULL” in line 24 and substitute “TRAUMATIC INJURY TO THE BRAIN CAUSING AN IMMEDIATE AND, USUALLY, SHORT-LIVED CHANGE IN MENTAL STATUS OR AN ALTERATION OF NORMAL CONSCIOUSNESS RESULTING FROM:

**(I) A FALL;**

**(II) A VIOLENT BLOW TO THE HEAD OR BODY; OR**

**(III) THE SHAKING OR SPINNING OF THE HEAD OR BODY”;**

in line 25, strike “A STUDENT” and substitute “AN INDIVIDUAL WHO IS 17 YEARS OLD OR YOUNGER OR WHO IS A PHYSICALLY OR MENTALLY DISABLED INDIVIDUAL OF ANY AGE”; in line 26, after “IN” insert “AN ATHLETIC ACTIVITY IN ASSOCIATION WITH”; in line 27, strike “INTERSCHOLASTIC ATHLETIC ACTIVITY” and substitute “EDUCATIONAL INSTITUTION”; in line 29, strike “AT” and substitute “:

**1. AT”;**

(Over)

and in the same line, after “FACILITY” insert “; OR”

**2. BY A RECREATIONAL ATHLETIC ORGANIZATION**”.

**AMENDMENT NO. 3**

On page 3, in line 8, strike “AND TRAINING”; in line 14, after “OF” insert “LICENSED”; in line 17, after “FOR” insert “REMOVAL FROM AND”; in line 20, strike “VERIFICATION”; in the same line, after “PROCESS” insert “TO VERIFY”; in line 21, strike “THE TRAINING REQUIRED” and substitute “INFORMATION RELATING TO THE PROGRAM DEVELOPED”; and in line 23, strike “ON AN ANNUAL BASIS, BEFORE” and substitute “BEFORE”.

**AMENDMENT NO. 4**

On page 4, in line 5, strike the colon and substitute “HAS OBTAINED WRITTEN CLEARANCE BY A LICENSED HEALTH CARE PROFESSIONAL.”; and strike in their entirety lines 6 through 34, inclusive.

On page 5, in line 1, strike “(3)” and substitute “(D)”; strike beginning with the colon in line 2 down through “A” in line 3 and substitute “A”; and strike beginning with the semicolon in line 5 down through “SUBSECTION” in line 21.
