AMENDMENTS TO HOUSE BILL 936, AS AMENDED  
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1 of the Judicial Proceedings Committee Amendments (HB0936/418870/1), in line 3 of Amendment No. 1, strike “and”; and in the same line, after “Procedures” insert “, and Notation on Driver’s License”.

AMENDMENT NO. 2

On page 2 of the bill, in line 44, after “information;” insert “requiring the Department of Public Safety and Correctional Services, within a certain period of time after receiving a sexual offender registration statement, to send a copy of the registration statement to the Motor Vehicle Administration;”.

AMENDMENT NO. 3

On page 3 of the Judicial Proceedings Committee Amendments, in line 4 of Amendment No. 1, after “Code;” insert “requiring the Motor Vehicle Administration, on receipt of a certain notice, to place a prominent notation on the driver’s license or identification card issued to the individual who is the subject of the notice indicating that the individual is a sexual offender registrant; prohibiting the removal of a certain notation unless the Department provides a certain written notice to the Administration;”; in line 8, strike “and”; in line 9, after “procedures” insert “, and notations on drivers’ licenses”; and in line 19, after “Supplement)” insert:

“BY adding to

Article – Transportation

Section 12-303.2

Annotated Code of Maryland

(2009 Replacement Volume and 2009 Supplement)”.

AMENDMENT NO. 4

On page 32 of the bill, in line 24, strike “AND”; and in line 27, after “REGISTRATION” insert “;AND”

(7) SHALL, WITHIN 5 WORKING DAYS AFTER RECEIVING A REGISTRATION STATEMENT UNDER THIS SUBTITLE, SEND A COPY OF THE REGISTRATION STATEMENT TO THE MOTOR VEHICLE ADMINISTRATION”.

AMENDMENT NO. 5

On page 17 of the Judicial Proceedings Committee Amendments, in the second line from the bottom of Amendment No. 4, after “ARTICLE.” insert:

“Article – Transportation

(A) ON RECEIPT OF NOTICE FROM THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES IN ACCORDANCE WITH § 11-713 OF THE CRIMINAL PROCEDURE ARTICLE THAT AN INDIVIDUAL WHO IS A HOLDER OF OR AN APPLICANT FOR A DRIVER’S LICENSE HAS REGISTERED UNDER § 11-704 OF THE CRIMINAL PROCEDURE ARTICLE, THE ADMINISTRATION SHALL PLACE ON A DRIVER’S LICENSE OR IDENTIFICATION CARD ISSUED OR REISSUED TO THE INDIVIDUAL, A PROMINENT NOTATION INDICATING THAT THE INDIVIDUAL IS A SEXUAL OFFENDER REGISTRANT.

(B) A NOTATION PLACED IN ACCORDANCE WITH THIS SECTION MAY BE REMOVED FROM A DRIVER’S LICENSE ONLY IF THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES PROVIDES WRITTEN NOTICE TO THE ADMINISTRATION THAT THE INDIVIDUAL IS NO LONGER SUBJECT TO
