AMENDMENT NO. 1

On page 1, in line 4, before "<u>Education</u>" insert "<u>State Department of</u>"; strike beginning with "<u>Children</u>" in line 4 down through "<u>Growth</u>" in line 6 and substitute "<u>Personal Financial Literacy State Curriculum</u>"; and strike beginning with "<u>superintendent</u>" in line 11 down through "<u>program</u>;" in line 20 and substitute "<u>board</u> <u>of education to make certain certifications regarding a certain curriculum on or before</u> <u>a certain date each year</u>; requiring the State Department of Education to develop a <u>process to monitor certain implementation of a certain curriculum</u>; requiring the <u>Department to report certain information to the Governor and General Assembly on or</u> <u>before a certain date each year</u>; expressing a certain intent of the General Assembly; <u>defining a certain term</u>;".

On page 2, in line 1, after the first "<u>the</u>" insert "<u>monitoring and</u>"; strike beginning with "<u>programs</u>" in line 1 down through "<u>State</u>" in line 2 and substitute "<u>the</u> <u>Personal Financial Literacy State Curriculum</u>"; and strike in their entirety lines 8 through 17, inclusive.

AMENDMENT NO. 2

On page 2, after line 21, insert:

"(A) IN THIS SECTION, "PERSONAL FINANCIAL LITERACY STATE CURRICULUM" MEANS THE CONTENT STANDARDS FOR PERSONAL FINANCIAL LITERACY THAT HAVE BEEN DEVELOPED BY THE DEPARTMENT AND APPROVED BY THE STATE BOARD.

(C) <u>The Department shall develop a process to monitor</u> <u>implementation of the Personal Financial Literacy State</u> <u>Curriculum.</u>

SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that the State Department of Education strongly consider requiring a measurement of financial literacy as a condition of graduation from public high schools in the State.".
