2 **State Board of Barbers and State Board of Cosmetologists – Sunset Extension**  
3 **and Revisions**

4 FOR the purpose of continuing the State Board of Barbers and the State Board of  
5 Cosmetologists (boards) in accordance with the provisions of the Maryland  
6 Program Evaluation Act (sunset law) by extending to a certain date the  
7 termination provisions relating to the statutory and regulatory authority of the  
8 boards; ~~altering the membership composition of the boards; prohibiting the~~  
9 ~~boards from setting certain fees that exceed a certain amount;~~ requiring the  
10 boards to adopt certain regulations regarding certain curriculum standards;  
11 altering the requirements for the renewal of certain licenses issued by the  
12 boards; repealing a requirement that certain complaints be signed by a  
13 complainant; requiring certain complaints to contain certain information;  
14 altering the procedures for the inspection of certain barbershops, beauty salons,  
15 and cosmetology schools; providing that an individual may renew a certain  
16 apprentice registration one time; repealing the requirement that certain  
17 apprentice barbers take a certain examination at a certain time and authorizing  
18 the renewal of a certain apprentice registration based on the failure of a certain  
19 examination; requiring the State Board of Cosmetologists to reimburse certain  
20 inspectors for certain expenses under the Standard State Travel Regulations;

20 inspector finds an unsanitary condition, the inspector promptly shall report the  
21 condition to the Board.

22 **(D) (1) A BARBERSHOP SHALL ALLOW AN INSPECTOR, ON**  
23 **PRESENTATION OF CREDENTIALS, TO ENTER AND INSPECT THE FACILITY AT**  
24 **ANY TIME DURING BUSINESS HOURS.**

25 **(2) DURING INSPECTION OF A BARBERSHOP, THE OWNER,**  
26 **LESSEE, OR MANAGER OF THE BARBERSHOP SHALL ACCOMPANY THE**  
27 **INSPECTOR.**

28 **(E) (1) AN INSPECTOR SHALL MAKE AN INSPECTION REPORT AFTER**  
29 **AN INSPECTION AND GIVE A COPY TO THE INDIVIDUAL WHO ACCOMPANIED THE**
