2 **Health Occupations – Licensure of Physician Assistants**

3 FOR the purpose of requiring an individual to be licensed rather than certified by the
4 State Board of Physicians before the individual may practice as a physician
5 assistant; ~~repealing certain language prohibiting a physician assistant from~~
6 ~~practicing within the scope of certain health occupations~~; requiring hospitals,
7 related institutions, alternative health care systems and employers to report to
8 the ~~State~~ Board certain changes in the terms of employment of physician
9 assistants; making certain exceptions for alcohol- or drug-impaired physician
10 assistants; authorizing the ~~State~~ Board to impose a certain civil penalty for
11 failure to make a certain report; ~~repealing the Physician Assistant Advisory~~
12 ~~Committee within the State Board and certain provisions of law relating to the~~
13 ~~Committee~~; altering the appointments and qualifications for members of the
14 Physician Assistant Advisory Committee within the Board; authorizing the
15 Board, rather than the Secretary of Health, to recommend the removal of
16 certain members of the Committee; authorizing the Executive Director of the
17 Board and certain agents or investigators to enter certain premises under
18 certain circumstances; prohibiting a person from denying or interfering with the
19 entry on premises under certain circumstances; providing for a certain criminal
20 penalty; repealing certain obsolete language; ~~limiting the scope of practice of~~
21 ~~physician assistants to certain medical acts~~; ~~repealing~~ altering the authority of
22 the ~~State~~ Board to review and approve certain delegation agreements; requiring
23 physicians to file completed delegation agreements with the ~~State~~ Board in

25 ~~perform certain functions that are delegated by primary or alternate~~

 18 practice of medicine delegated by a physician under Title 14 of this article.

 20 PRIMARY supervising physician and a physician assistant containing the
 21 requirements of ~~[§ 15–302] §§ 15–302 AND 15–302.1~~ of this title.

22 [(j) “Designated pharmacy” means a pharmacy that has an agreement to
 23 supply medications for a hospital, public health facility, correctional facility, or
 24 detention center if:

25 (1) The hospital, public health facility, correctional facility, or
 26 detention center does not have an on–site pharmacy; or

27 (2) The on–site pharmacy at the hospital, public health facility,
 28 correctional facility, or detention center is closed or does not have a particular
 29 medication in stock.]

30 (J) “DISPENSE” MEANS TO DISPENSE DRUG SAMPLES OR STARTER
 31 DOSAGES.

1 **(K) “DRUG SAMPLE” MEANS A UNIT OF A PRESCRIPTION DRUG THAT IS**
 2 **INTENDED TO PROMOTE THE SALE OF THE DRUG AND IS NOT INTENDED FOR**
 3 **SALE.**

5 (1) A hospital as defined under § 19–301 of the Health – General
 6 Article;

7 (2) A comprehensive care facility that:

8 (i) Meets the requirements of a hospital–based skilled nursing

 24 **LICENSED** under this title to [perform delegated medical acts under the supervision of
 25 a] **PRACTICE MEDICINE WITH physician SUPERVISION.**

 27 medical acts that are:

28 (1) Delegated by a ~~PRIMARY OR ALTERNATE~~ supervising physician to
 29 a physician assistant;

30 (2) Within the ~~PRIMARY OR ALTERNATE~~ supervising physician’s
 31 scope of practice; and

1 (3) Appropriate to the physician assistant's education, training, and
 2 experience ~~AS DETERMINED BY THE PRIMARY SUPERVISING PHYSICIAN.~~

3 [(o)] ~~(M)~~ (Q) "Prescriptive authority" means the authority delegated by a
 4 PRIMARY OR ALTERNATE supervising physician to a physician assistant to
 5 [prescribe]:

6 (1) **PRESCRIBE** and administer controlled dangerous substances,
 7 prescription drugs, medical devices, and the oral, written, or electronic ordering of
 8 medications; AND

9 (2) **DISPENSE AS PROVIDED UNDER § 15-301.1(C), (D), AND (E)**
 10 **OF THIS TITLE.**

23 (1) THE HOSPITAL, RELATED INSTITUTION, ALTERNATIVE
24 HEALTH SYSTEM, OR EMPLOYER KNOWS THAT THE PHYSICIAN ASSISTANT IS:

25 (i) IN AN ALCOHOL OR DRUG TREATMENT PROGRAM THAT
26 IS ACCREDITED BY THE JOINT COMMISSION ON THE ACCREDITATION OF
27 HEALTHCARE ORGANIZATIONS OR IS CERTIFIED BY THE DEPARTMENT; OR

28 (ii) UNDER THE CARE OF A HEALTH CARE PRACTITIONER
29 WHO IS COMPETENT AND CAPABLE OF DEALING WITH ALCOHOLISM AND DRUG
30 ABUSE;

31 (2) THE HOSPITAL, RELATED INSTITUTION, ALTERNATIVE
32 HEALTH SYSTEM, OR EMPLOYER IS ABLE TO VERIFY THAT THE PHYSICIAN
33 ASSISTANT REMAINS IN THE TREATMENT PROGRAM UNTIL DISCHARGE; AND

4 **ORGANIZATIONS OR THAT IS CERTIFIED BY THE DEPARTMENT, THE PHYSICIAN**

19 **PROGRAM SHALL NOTIFY THE HOSPITAL, RELATED INSTITUTION, ALTERNATIVE**
20 **HEALTH SYSTEM, OR EMPLOYER OF THE PHYSICIAN ASSISTANT'S**

28 (A) IF AFTER A HEARING UNDER § 15-315 OF THIS SUBTITLE, THE
29 BOARD FINDS THAT THERE ARE GROUNDS FOR DISCIPLINE UNDER § 15-314(A)
30 OF THIS SUBTITLE TO SUSPEND OR REVOKE A LICENSE OF A PHYSICIAN
31 ASSISTANT OR TO DENY A LICENSE TO AN APPLICANT OR TO REPRIMAND A
32 LICENSED PHYSICIAN ASSISTANT, THE BOARD MAY IMPOSE A FINE SUBJECT TO
33 THE BOARD'S REGULATIONS INSTEAD OF OR IN ADDITION TO SUSPENDING OR
34 REVOKING THE LICENSE OR REPRIMANDING THE LICENSEE.

1 **(B) THE BOARD SHALL PAY ANY FINES COLLECTED UNDER THIS**
2 **SECTION INTO THE GENERAL FUND OF THE STATE.**

4 **(A) A PHYSICIAN ASSISTANT IN THIS STATE OR IN ANY OTHER STATE IS**
5 **AUTHORIZED TO PERFORM ACTS, TASKS, OR FUNCTIONS AS A PHYSICIAN**
6 **ASSISTANT UNDER THE SUPERVISION OF A PHYSICIAN LICENSED TO PRACTICE**
7 **MEDICINE IN THE STATE DURING A DISASTER AS DEFINED BY THE GOVERNOR,**
8 **WITHIN A COUNTY IN WHICH A STATE OF DISASTER HAS BEEN DECLARED, OR**
9 **COUNTIES CONTIGUOUS TO A COUNTY IN WHICH A STATE OF DISASTER HAS**
10 **BEEN DECLARED.**

11 **(B) THE PHYSICIAN ASSISTANT SHALL NOTIFY THE BOARD IN WRITING**
12 **OF THE NAMES, PRACTICE LOCATIONS, AND TELEPHONE NUMBERS FOR THE**

18 **MAINTAIN ON-SITE DOCUMENTATION DESCRIBING SUPERVISORY**

21 (a) Except as otherwise provided in this title, a person may not practice,
22 attempt to practice, or offer to practice as a physician assistant in the State unless the
23 person has a [certificate] **LICENSE** issued by the Board.

24 (b) Except as otherwise provided in this title, a person may not perform,
25 attempt to perform, or offer to perform any delegated medical act beyond the scope of
26 the [certificate] **LICENSE** and which is consistent with a delegation agreement
27 [approved by] **FILED WITH** the Board.

29 (a) Except as otherwise provided under this title, a person may not represent
30 or imply to the public by use of the title [“certified”] **“LICENSED physician assistant”**,
31 by other title, by description of services, methods, or procedures that the person is
32 [certified] **LICENSED** to practice as a physician assistant in the State.

33 (b) Unless [certified] **LICENSED** to practice as a physician assistant under
34 this title, a person may not use the words or terms “physician assistant”, [“certified”]
35 **“LICENSED physician assistant”**, or “P.A.”.

2 **(A) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, A LICENSED**
3 **PHYSICIAN MAY NOT EMPLOY OR SUPERVISE AN INDIVIDUAL PRACTICING AS A**
4 **PHYSICIAN ASSISTANT WHO DOES NOT HAVE A LICENSE.**

5 **(B) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, A HOSPITAL,**
6 **RELATED INSTITUTION, ALTERNATIVE HEALTH CARE SYSTEM, OR EMPLOYER**
7 **MAY NOT EMPLOY AN INDIVIDUAL PRACTICING AS A PHYSICIAN ASSISTANT WHO**

14 (a) A person who violates § 15-401 or § 15-402 of this subtitle:

15 (1) Is guilty of a misdemeanor and on conviction is subject to a fine not
16 exceeding \$5,000 or imprisonment not exceeding 5 years or both; and

17 (2) Shall lose [certification] LICENSURE as a physician assistant
18 under this title.
