A BILL ENTITLED

1 AN ACT concerning

2 **Energy Performance Ratings – State, County, and Municipal Buildings**

3 FOR the purpose of requiring, beginning on a certain date, the governing body of a
4 county or a municipal corporation to post a certain Energy Star rating for
5 certain county or municipal buildings in a certain area of the buildings;
6 beginning on certain dates, requiring the Department of General Services to
7 post a certain Energy Star rating for certain State buildings in a certain area of
8 the buildings; defining certain terms; and generally relating to the energy
9 performance of State, county, and municipal buildings.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article 24 – Political Subdivisions – Miscellaneous Provisions**

1 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**
2 **MEANINGS INDICATED.**

3 **(2) “BUILDING” HAS THE MEANING STATED IN § 4-808.1(A) OF**
4 **THE STATE FINANCE AND PROCUREMENT ARTICLE.**

5 **(3) “ENERGY STAR RATING” HAS THE MEANING STATED IN §**
6 **4-808.1(A) OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

7 **(B) BEGINNING OCTOBER 1, 2011, THE GOVERNING BODY OF A COUNTY**
8 **OR MUNICIPAL CORPORATION SHALL POST THE ENERGY STAR RATING OF EACH**
9 **BUILDING OWNED OR OPERATED BY THE COUNTY OR MUNICIPAL CORPORATION**
10 **IN AN AREA OF THE BUILDING THAT IS OPEN AND ACCESSIBLE TO THE PUBLIC.**

13 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**
14 **MEANINGS INDICATED.**

15 **(2) “BUILDING” MEANS ANY ENCLOSED STRUCTURE THAT**
16 **PROVIDES A METHOD OF CONTROLLING ENERGY USAGE WITHIN ITS INTERIOR.**

17 **(3) “ENERGY STAR RATING” MEANS THE ENERGY PERFORMANCE**
18 **RATING OF A BUILDING AS DETERMINED BY THE U.S. ENVIRONMENTAL**
19 **PROTECTION AGENCY’S ENERGY STAR PORTFOLIO MANAGER RATING**
20 **SYSTEM.**

21 **(B) THE DEPARTMENT SHALL POST THE ENERGY STAR RATING OF**
22 **EACH BUILDING OWNED OR OPERATED BY THE STATE IN AN AREA OF THE**
23 **BUILDING THAT IS OPEN AND ACCESSIBLE TO THE PUBLIC BEGINNING:**

24 **(1) OCTOBER 1, 2010, FOR BUILDINGS WITH AN ENCLOSED SPACE**
25 **OF 100,000 SQUARE FEET OR MORE; AND**

26 **(2) OCTOBER 1, 2011, FOR BUILDINGS WITH AN ENCLOSED SPACE**
27 **OF LESS THAN 100,000 SQUARE FEET.**

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
29 October 1, 2010.
