## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Maryland Uniform Adult Guardianship and Protective Proceedings**  
3 **Jurisdiction Act**

4 FOR the purpose of establishing the Maryland Uniform Adult Guardianship and  
5 Protective Proceedings Jurisdiction Act; authorizing a court of this State to  
6 treat a foreign country as if the country were a state for the purpose of applying  
7 certain provisions of this Act; prohibiting a court of this State from treating a  
8 foreign country as if the country were a state for the purposes of applying  
9 certain provisions of this Act unless a court of this State makes a certain  
10 finding; authorizing a court of this State to make a certain request of an  
11 appropriate court of another state in a certain guardianship or protective  
12 proceeding in this State and to grant a certain request from an appropriate  
13 court of another state in a certain guardianship or protective proceeding in that  
14 state; authorizing the offer of testimony by deposition or certain other means in  
15 a certain guardianship or protective proceeding; requiring a court of this State  
16 to cooperate with courts of other states in designating an appropriate location  
17 for a deposition or testimony in a certain guardianship or protective proceeding;  
18 establishing that a court of this State has jurisdiction to appoint a guardian or

1 issue a protective order for a certain respondent under certain circumstances;  
2 establishing that a court of this State that lacks certain jurisdiction under this  
3 Act has special jurisdiction to take certain steps; requiring a court in this State  
4 to dismiss a certain proceeding at the request of a certain court in another state  
5 under certain circumstances; establishing that a court that has appointed a  
6 guardian or issued a protective order consistent with this Act has exclusive and  
7 continuing jurisdiction over the proceeding until the proceeding is terminated  
8 by the court or the appointment or order expires by the terms of the  
9 appointment or order; authorizing a court to decline to exercise jurisdiction  
10 under certain circumstances; requiring a court that declines jurisdiction to take  
11 certain steps in certain circumstances; authorizing a court to take certain steps  
12 if a certain determination is made; requiring a certain petitioner to provide  
13 certain notice to certain persons; authorizing a court to proceed or requiring the  
14 court to take certain steps on the filing of a certain petition under certain  
15 circumstances; authorizing a certain guardian or conservator to petition a court  
16 to transfer a guardianship or conservatorship to another state under certain  
17 circumstances; providing that a certain notice of a petition to transfer a  
18 guardianship or conservatorship to another state be given under certain  
19 circumstances; requiring a court to hold a hearing on a certain petition under  
20 certain circumstances; requiring a court to issue a provisional order granting a  
21 petition to transfer a guardianship or conservatorship to another state on a  
22 certain finding; requiring a guardian or conservator to petition a court in this  
23 State to accept a certain guardianship or conservatorship under certain  
24 circumstances; providing that a certain notice of a petition to accept a  
25 guardianship or conservatorship be given under certain circumstances;  
26 requiring a court to hold a hearing on a certain petition under certain  
27 circumstances; requiring a court to issue a provisional order approving a certain  
28 petition unless a certain objection is made; requiring a court to recognize a  
29 guardianship or conservatorship order from another state under certain  
30 circumstances; establishing that the denial of a petition to accept a  
31 guardianship or conservatorship from another state does not affect the ability of  
32 a certain person to seek a certain court appointment; authorizing a guardian  
33 appointed in another state to register a certain guardianship order in this State  
34 as a foreign judgment under certain circumstances; authorizing a conservator  
35 appointed in another state to register a certain conservatorship order in this  
36 State as a foreign judgment under certain circumstances; authorizing, with  
37 certain exceptions, a certain guardian or conservator to exercise certain powers  
38 in this State; authorizing a court in this State to grant certain relief to enforce a  
39 certain registered order; providing for the application of this Act; establishing  
40 that this Act modifies, limits, and supersedes certain provisions of federal law;  
41 making certain technical corrections; defining certain terms; and generally  
42 relating to adult guardianship and protective proceedings.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Estates and Trusts**

18 13–101.

19 (a) In this title the following words have the meanings indicated.

20 (e) “Disabled person” means a person other than a minor who:

21 (1) (i) Has been judged by a court to be unable to manage his  
22 property for reasons listed in § 13–201(c)(1) of this title; and

23 (ii) As a result of this inability requires a guardian of his  
24 property; or

25 (2) (i) Has been judged by a court to be unable to provide for his  
26 daily needs sufficiently to protect his health or safety for reasons listed in § 13–705(b)  
27 of this title; and

28 (ii) As a result of this inability requires a guardian of the  
29 person.

30 (h) “Guardian” means a guardian of an estate appointed by a court under  
31 Subtitle 2 of this title to manage the property of a disabled person or minor or a  
32 guardian of a person appointed by a court under Subtitle 7 of this title, according to  
33 the context in which it is used.

34 13–105.

1 (a) (1) The orphans' courts and the circuit courts have concurrent  
2 jurisdiction over guardians of the person of a minor and over protective proceedings for  
3 minors.

4 (2) Upon petition of an interested person, a matter initiated in the  
5 orphans' court may be transferred to the circuit court.

6 (b) **[The] SUBJECT TO TITLE 13.5 OF THIS ARTICLE, THE** circuit courts  
7 have exclusive jurisdiction over protective proceedings for disabled persons.

8 (c) (1) An orphans' court may exercise jurisdiction over guardianship of  
9 the person of a minor if the presiding judge of the orphans' court is a member of the  
10 bar, regardless of whether the minor who is the subject of the petition for  
11 guardianship of the person has property, may inherit property, or is destitute.

12 (2) An orphans' court that exercises jurisdiction or is requested to  
13 exercise jurisdiction under this subsection may:

14 (i) Transfer the matter to the circuit court on a finding that the  
15 best interests of the child require utilization of the equitable powers of the circuit  
16 court; and

17 (ii) Waive the costs, if any, of a transfer under this paragraph.

18 13–201.

19 (a) Upon petition, and after any notice or hearing prescribed by law or the  
20 Maryland Rules, the court may appoint a guardian of the property of a minor or a  
21 disabled person.

22 (b) A guardian shall be appointed if the court determines that:

23 (1) A minor owns or is entitled to property that requires management  
24 or protection; or

25 (2) Funds are needed for his support, care, welfare, and education and  
26 protection is necessary or desirable to obtain or provide funds.

27 (c) A guardian shall be appointed if the court determines that:

28 (1) The person is unable to manage his property and affairs effectively  
29 because of physical or mental disability, disease, habitual drunkenness, addiction to  
30 drugs, imprisonment, compulsory hospitalization, confinement, detention by a foreign  
31 power, or disappearance; and

1           (2)    The person has or may be entitled to property or benefits which  
2 require proper management.

3   13–202.

4           Venue in proceedings under this subtitle shall be as provided by the Maryland  
5 Rules.

6   13–203.

7           (a)    While a petition for appointment of a guardian or other protective order  
8 is pending, the court may preserve and apply the property of the alleged disabled  
9 person or minor as may be required. The court need not give notice to other persons.

10           (b)    The court may not exercise the power conferred by subsection (a) unless it  
11 appears from specific facts shown by affidavit that immediate, substantial, and  
12 irreparable injury will result to the applicant or to the minor or disabled person before  
13 an adversary hearing can be held. The court may communicate informally with the  
14 minor or disabled person prior to taking action. Any order shall be served immediately  
15 on the minor or disabled person.

16           (c)    (1)    Except for the limitations contained in § 13–106 of this title, after  
17 appointment of the guardian, the court has all the powers over the property of the  
18 minor or disabled person that the person could exercise if not disabled or a minor.

19                   (2)    The powers that a circuit court has under paragraph (1) of this  
20 subsection include the power to authorize or direct the guardian to:

21                           (i)    Make gifts from the principal and income of the estate; and

22                           (ii)   Disclaim on behalf of the minor or disabled person, in whole  
23 or in part, the right of succession or transfer to that person of any property or interest  
24 in any property.

25                   (3)    The powers that a circuit court has under paragraph (2) of this  
26 subsection are in addition to and may not limit the power:

27                           (i)    Conferred upon the guardian to make distributions under §  
28 13–214 of this subtitle; and

29                           (ii)   Conferred upon the guardian or the circuit court, without  
30 appointing a guardian, to disclaim or authorize or direct a disclaimer on behalf of a  
31 minor or disabled person under § 9–201(c) of this article.

32           (d)    A guardian or any other interested person may invoke the jurisdiction of  
33 the court at any time to resolve questions concerning the estate or its administration.

1 13-204.

2 (a) If a basis exists as described in § 13-201 of this subtitle for assuming  
3 jurisdiction over the property of a minor or disabled person, the circuit court, without  
4 appointing a guardian, may authorize or direct a transaction with respect to the  
5 property, service, or care arrangement of the minor or disabled person. These  
6 transactions include but are not limited to:

7 (1) Payment, delivery, deposit, or retention of funds or property;

8 (2) Sale, mortgage, lease, or other transfer of property;

9 (3) Purchase of contracts for an annuity, life care, training, or  
10 education; or

11 (4) Any other transaction described in:

12 (i) § 13-203(c)(2) of this subtitle;

13 (ii) Title 9, Subtitle 2 of this article; or

14 (iii) § 15-102 of this article.

15 (b) Before approving a transaction or arrangement under this section, the  
16 court shall consider the interests of creditors and dependents of the minor or disabled  
17 person and whether the property of the minor or disabled person needs the continuing  
18 protection provided by a guardian.

19 13-205.

20 An adjudication under this subtitle shall have no bearing on the issue of  
21 capacity of the alleged disabled person to care for his own person.

22 13-206.

23 (a) Subject to the provisions of § 13-207 of this subtitle, the court may  
24 appoint as guardian of the estate of a minor or disabled person:

25 (1) Any individual;

26 (2) Any trust company; or

27 (3) Any other corporation authorized by law to serve as a trustee.

28 (b) The appointed guardian shall qualify by filing any required bond.

1           (c)   (1)   The appointment and qualification of a guardian vests in him title  
2 to all property of the minor or protected person that is held at the time of appointment  
3 or acquired later. The appointment is not a transfer or alienation within the meaning  
4 of any federal or State statute or regulation, insurance policy, pension plan, contract,  
5 will, or trust instrument that imposes restrictions on or penalties for transfer or  
6 alienation by the minor or disabled person of his rights or interest. A guardian shall  
7 utilize powers conferred by this subtitle to perform the services, exercise his  
8 discretion, and discharge his duties for the best interest of the minor or disabled  
9 person or his dependents.

10           (2)   If a trust company is appointed guardian, a court may order any  
11 money paid to the court for the benefit of the minor or disabled person to be deposited  
12 with the trust company.

13           (d)   The guardian is the statutory agent of the minor or disabled person for  
14 the purpose of filing all government reports and returns.

15 13–207.

16           (a)   Persons are entitled to appointment as guardian for a minor or disabled  
17 person according to the following priorities:

18           (1)   A conservator, committee, guardian of property, or other like  
19 fiduciary appointed by any appropriate court of any foreign jurisdiction in which the  
20 minor or disabled person resides;

21           (2)   A person or corporation nominated by the minor or disabled person  
22 if the designation was signed by the minor or disabled person after his 16th birthday,  
23 and, in the opinion of the court, he had sufficient mental capacity to make an  
24 intelligent choice at the time he executed the designation;

25           (3)   His spouse;

26           (4)   His parents;

27           (5)   A person or corporation nominated by the will of a deceased  
28 parent;

29           (6)   His children;

30           (7)   The persons who would be his heirs if he were dead;

31           (8)   A person or corporation nominated by a person who, or institution,  
32 organization, or public agency which, is caring for him;

33           (9)   A person or corporation nominated by a governmental agency  
34 which is paying benefits to him; **AND**

1 (10) Any other person considered appropriate by the court.

2 (b) A person specified in a priority in subsection (a)(1), (3), (4), (6) or (7) may  
3 waive and nominate in writing a person or corporation to serve in his stead. A  
4 nominee of a person holding a priority has the same priority as the person making the  
5 nomination.

6 (c) Among persons with equal priority, the court shall select the one best  
7 qualified of those willing to serve. For good cause the court may pass over a person  
8 with priority and appoint a person with less priority or no priority.

9 (d) Nonresidence does not disqualify any person from serving as guardian.  
10 Any nonresident who is appointed cannot qualify until he has on file with the register  
11 or clerk an irrevocable designation by him of an appropriate person who resides in the  
12 State on whom service of process may be made in the same manner and with the effect  
13 as if it were served personally in the State on the nonresident.

14 (e) The court may not name an official or employee of a local department of  
15 social services, the State Department of Human Resources, a local area agency on  
16 aging as defined in § 10–101 of the Human Services Article, or the Department of  
17 Aging as guardian of the estate.

18 13–208.

19 (a) Where the instrument nominating a guardian excuses a noncorporate  
20 guardian from furnishing bond, the court shall not require a bond unless exceptional  
21 circumstances are shown to exist which make it necessary to require a bond for the  
22 safety of those interested in the administration of the estate.

23 (b) A corporate guardian shall not be required to furnish bond.

24 (c) In the case of a noncorporate guardian, including a substituted or  
25 successor or reinstated guardian nominated by the court or nominated under an  
26 instrument which is silent as to bond, the court may, subject to subsection (d) of this  
27 section, require a bond if, in its discretion, it finds it necessary for the safety of those  
28 interested in the administration of the estate.

29 (d) In a guardian estate consisting entirely of cash, deposited as provided in  
30 the rules, securities or real property, or any combination of them which cannot be  
31 transferred by the guardian without the approval of the court, not exceeding \$10,000,  
32 the court shall not require a guardian to furnish or continue in effect a bond, unless  
33 exceptional circumstances are shown to exist.

34 (e) The penalty of the bond shall not be greater than the aggregate value of  
35 the property of the estate under the control of the guardian, less the value of securities  
36 or money deposited in a financial institution as defined in § 13–301(h) of this title



1 under arrangements requiring an order of the court for their removal, and the value of  
2 any land which the guardian, by express limitation of power, lacks power to sell or  
3 convey without court authorization. The court may, in lieu of sureties on a bond,  
4 accept other security for the performance of the bond, including a pledge of securities  
5 or a mortgage of land. The court may at any time, subject to the maximum penalty  
6 provided by this section, require the amount of the bond, or the type or value of  
7 security, to be changed. The approval of a new bond shall not discharge a bond filed  
8 previously from any liability which may have accrued before approval.

9 (f) The terms of any bond shall be as provided by the Maryland Rules.

10 13-209.

11 Inventory and accounting in proceedings under this subtitle shall be as provided  
12 by the Maryland Rules.

13 13-210.

14 (a) An interested person may file a petition for an order:

15 (1) Requiring bond, security, additional bond, or security in an estate  
16 where bond can be required;

17 (2) Requiring an accounting of the administration of the estate;

18 (3) Directing distribution;

19 (4) Removing the guardian and appointing a successor guardian; or

20 (5) Granting other appropriate relief.

21 (b) A guardian may petition the appointing court for permission to act in any  
22 matter relating to the administration of the estate.

23 (c) Upon hearing after notice and upon good cause shown, the court may  
24 issue an appropriate order.

25 13-211.

26 (a) There shall be no jury trial in protective proceedings. Procedures for  
27 notice to interested persons, the forms of petitions, and the conduct of and  
28 requirements at hearings are as provided in the Maryland Rules.

29 (b) Unless the alleged disabled person has counsel of his own choice, the  
30 court shall appoint an attorney to represent him in the proceeding.

31 13-212.

1           In the administration of the estate and the exercise of his powers, a guardian  
2 shall exercise the care and skill of a man of ordinary prudence dealing with his own  
3 property.

4   13–213.

5           All the provisions of § 15–102 of this article with respect to the powers of a  
6 fiduciary and the manner of exercise of those powers are applicable to a guardian.

7   13–214.

8           (a)   A guardian may distribute or disburse property without court  
9 authorization or confirmation in accordance with this section.

10           (b)   (1)   A guardian of a minor may pay or apply income and principal from  
11 the estate as needed for the clothing, support, care, protection, welfare, and education  
12 of the minor.

13                   (2)   A guardian of a disabled person may pay or apply income and  
14 principal from the estate as needed for the clothing, support, care, protection, welfare,  
15 and rehabilitation of the disabled person. He shall give consideration to the support  
16 and care of the disabled person during the probable period of the estate and the needs  
17 of persons dependent upon the disabled person.

18                   (3)   Income and principal also may be paid or applied for the benefit of  
19 persons legally dependent upon the minor or disabled person and, with the approval of  
20 the court, for the benefit of other persons maintained and supported in whole or in  
21 part by the disabled person prior to the appointment of a guardian.

22           (c)   (1)   When a minor attains his majority, his guardian, after meeting all  
23 prior claims and expenses of administration, shall distribute the estate to the former  
24 minor as soon as possible, unless the minor is then disabled. The distribution normally  
25 shall be in kind.

26                   (2)   If the guardian is satisfied that the disability of the disabled  
27 person has ceased or if the court has found in a proceeding under § 13–221 of this  
28 subtitle that the disability has ceased, the guardian, after meeting all prior claims and  
29 expenses of administration, shall distribute the estate to the former disabled person as  
30 soon as possible. The distribution normally shall be in kind.

31                   (3)   When a minor or disabled person dies, the guardian shall deliver to  
32 the appropriate probate court for safekeeping any will of the deceased person in his  
33 possession, inform the personal representative or a beneficiary named in it that he has  
34 done so, and retain the estate for delivery to an appointed personal representative of  
35 the decedent or other person entitled to it.

1           (4) If a guardianship is terminated for reasons other than the  
2 attainment of majority, cessation of disability, or death of the protected person, the  
3 guardian shall distribute the estate in accordance with the order of the court  
4 terminating the guardianship.

5 13–215.

6           Any limitation on the powers of a guardian contained in a will or other  
7 instrument which nominated a guardian should ordinarily be imposed by the court on  
8 the guardian. If the court limits any power conferred on the guardian by § 13–214 of  
9 this subtitle or § 15–102 of this article, the limitation shall be endorsed upon his  
10 letters of appointment.

11 13–216.

12           (a) If the exercise of a power is improper, the guardian is liable for breach of  
13 his fiduciary duty to the minor or disabled person or to interested persons for resulting  
14 damage or loss to the same extent as a trustee of an express trust.

15           (b) The rights of purchasers and others dealing with a guardian shall be  
16 determined as provided in § 13–219 and are not necessarily affected by the fact that  
17 the guardian breached his fiduciary duty in the transaction.

18 13–217.

19           (a) Letters of guardianship may be recorded in the land records of the county  
20 of residence of the minor or disabled person and of any other county where there is  
21 real estate in which the estate has an interest. The recordation has the same effect as  
22 notice as recording a conveyance from the minor or disabled person to the guardian.

23           (b) Orders of the court modifying or terminating letters of guardianship or  
24 authorizing making a conveyance or doing any other act with respect to interests in  
25 real estate constituting part of the estate may be recorded in a similar manner and  
26 with similar effect.

27 13–218.

28           Except in unusual circumstances, the guardian is entitled to the same  
29 compensation and reimbursement for actual and necessary expenses as the trustee of  
30 a trust. No petition or hearing is required to entitle the guardian to compensation and  
31 expenses. Upon the petition of any interested person and upon a finding by the court  
32 that unusual circumstances exist, the court may increase or decrease compensation.

33 13–219.

34           In the absence of actual knowledge or of reasonable cause to inquire whether  
35 the guardian is improperly exercising his power, a person dealing with the guardian

1 need not inquire whether the guardian is exercising it properly, and is protected as if  
2 the guardian properly exercised the power, except that every person is charged with  
3 actual knowledge of any limitations endorsed on the letters of guardianship. A person  
4 need not see to the proper application of estate assets paid or delivered to a guardian.

5 13–220.

6 (a) The appointment of a guardian terminates when the guardianship  
7 terminates under § 13–221 and may be terminated sooner by his death, disability,  
8 resignation, or removal.

9 (b) Termination of appointment of a guardian has the effects provided in this  
10 section.

11 (1) Termination ends the right and power pertaining to the office of  
12 guardian. Unless otherwise ordered by the court, a guardian whose appointment has  
13 been terminated shall perform acts necessary to protect the estate and deliver the  
14 property to the successor guardian.

15 (2) Subject to the provisions of the Maryland Rules, termination does  
16 not discharge a guardian from liability for transactions or omissions occurring before  
17 termination, or relieve him of the duty to preserve, account for, and deliver to his  
18 successor property subject to his control.

19 (3) All lawful acts of a guardian before the termination of his  
20 appointment shall remain valid and effective.

21 (c) The death of a guardian or the decree of a court of competent jurisdiction  
22 that he is under legal disability shall terminate his appointment. The personal  
23 representative of a deceased guardian or the person appointed to protect the estate of  
24 a guardian under legal disability shall have the duty to protect property belonging to  
25 the estate being administered by the deceased or disabled guardian.

26 (1) He shall have the power to perform acts necessary for the  
27 protection of property.

28 (2) He shall immediately account for and deliver the property to a  
29 successor guardian.

30 (3) He shall apply immediately to the court for the appointment of a  
31 successor guardian to carry on the administration of the estate which was being  
32 administered by the deceased or disabled guardian in accordance with the Maryland  
33 Rules.

34 (d) A guardian who desires to resign his office may do so in accordance with  
35 the provisions of the same Maryland Rules by which a fiduciary may resign his office.

1 13-221.

2 (a) The minor or disabled person, his personal representative, the guardian,  
3 or any other interested person may petition the court to terminate the guardianship  
4 proceedings.

5 (b) A guardianship proceeding shall terminate upon:

6 (1) The cessation of the minority or disability;

7 (2) The death or presumptive death of the minor or disabled person;

8 (3) Transfer of all the assets of the estate to a foreign fiduciary; or

9 (4) Other good cause for termination as may be shown to the  
10 satisfaction of the court.

11 (c) Termination and final distribution of the estate of a former minor or  
12 disabled person shall be made in compliance with the provisions of the Maryland  
13 Rules, applying to a fiduciary.

14 13-222.

15 (a) [When no guardianship proceeding is pending in the state, a] A  
16 guardian, conservator, committee, or other similar fiduciary, appointed by the  
17 appropriate court of another jurisdiction to manage the property of a protected person  
18 who is a resident of that jurisdiction, may exercise in the state all powers of his office,  
19 including the power to sell, purchase, or mortgage real estate in the state, collect,  
20 receipt for, and take possession of money due, tangible personal property, or an  
21 instrument evidencing a debt, obligation, stock, or chose in action located in the state,  
22 and remove it to the other jurisdiction. Subject to any statute or rule relating to  
23 nonresidents, he may sue and be sued in the state.

24 (b) Before receiving actual notice of the pendency of a guardianship  
25 proceeding in the state, a person who has changed his position by relying on the  
26 powers granted by this section may not be prejudiced by the pendency of the  
27 proceeding.

28 13-704.

29 The court may superintend and direct the care of a disabled person, appoint a  
30 guardian of the person, and pass orders and decrees respecting the person as seems  
31 proper, including an order directing the disabled person to be sent to a hospital.  
32 Procedures in these cases shall be as prescribed by the Maryland Rules and in  
33 accordance with the provisions of this subtitle **AND TITLE 13.5 OF THIS ARTICLE.**

1 (a) On petition and after any notice or hearing prescribed by law or the  
2 Maryland Rules, a court may appoint a guardian of the person of a disabled person.

3 (b) A guardian of the person shall be appointed if the court determines from

13 certificates of competency from the following health care professionals:

14 (i) Two licensed physicians who have examined the disabled

16 (ii) 1. One licensed physician who has examined the

18 2. A. One licensed psychologist who has evaluated  
19 the disabled person; or

20 B. One licensed certified social worker—clinical who has  
21 evaluated the disabled person.

22 (3) An examination or evaluation by at least one of the health care  
23 professionals under paragraph (2) of this subsection shall occur within 21 days before  
24 filing a petition for guardianship of a disabled person.

25 (d) (1) Subject to paragraph (2) of this subsection, unless the alleged  
26 disabled person has counsel of his own choice, the court shall appoint an attorney to  
27 represent him in the proceeding. If the person is indigent, the State shall pay a

29 (2) In any action in which payment for the services of a  
30 court-appointed attorney for the alleged disabled person is the responsibility of the  
31 local department of social services, unless the court finds that it would not be in the  
32 best interests of the alleged disabled person, the court shall:

35 terms of the contract; and

1                   (ii) In an action in which an attorney has previously been  
2 appointed, strike the appearance of the attorney previously appointed and appoint the

5                   (e) The person alleged to be disabled is entitled to be present at the hearing  
6 unless he has knowingly and voluntarily waived the right to be present or cannot be  
7 present because of physical or mental incapacity. Waiver or incapacity may not be  
8 presumed from nonappearance but shall be determined on the basis of factual  
9 information supplied to the court by counsel or a representative appointed by the  
10 court. The person alleged to be disabled is also entitled to present evidence and to  
11 cross-examine witnesses. The issue may be determined at a closed hearing without a  
12 jury if the person alleged to be disabled or his counsel so requests and all hearings  
13 herein shall be confidential and sealed unless otherwise ordered by a court of  
14 competent jurisdiction for good cause shown.

15                   (f) The court shall hear and rule on a petition seeking appointment of a  
16 guardian of the person of a disabled person in connection with medical treatment on  
17 an expedited basis.

19                   (a) An adjudication of a disability for purposes of appointing a guardian of a  
20 person may not be the basis for commitment of the disabled person to a mental  
21 institution.

22                   (b) Appointment of a guardian of the person:

23                   (1) Is not evidence of incompetency of the disabled person; and

24                   (2) Does not modify any civil right of the disabled person unless the  
25 court orders, including any civil service ranking, appointment, and rights relating to  
26 licensure, permit, privilege, or benefit under any law.

27 13-707.

28                   (a) Persons are entitled to appointment as guardian of the person according  
29 to the following priorities:

30                   (1) A person, agency, or corporation nominated by the disabled person  
31 if the disabled person was 16 years old or older when the disabled person signed the  
32 designation and, in the opinion of the court, the disabled person had sufficient mental  
33 capacity to make an intelligent choice at the time the disabled person executed the  
34 designation;

1                   (2)    A health care agent appointed by the disabled person in accordance  
2 with Title 5, Subtitle 6 of the Health – General Article;

3                   (3)    The disabled person’s spouse;

4                   (4)    The disabled person’s parents;

5                   (5)    A person, agency, or corporation nominated by the will of a  
6 deceased parent;

7                   (6)    The disabled person’s children;

8                   (7)    Adult persons who would be the disabled person’s heirs if the  
9 disabled person were dead;

10                  (8)    A person, agency, or corporation nominated by a person caring for  
11 the disabled person;

12                  (9)    Any other person, agency, or corporation considered appropriate by  
13 the court; and

14                  (10) For adults less than 65 years old, the director of the local  
15 department of social services or, for adults 65 years old or older, the Secretary of Aging  
16 or the director of the area agency on aging, except in those cases where the  
17 department of social services has been appointed guardian of the person prior to age  
18 65. Upon appointment as guardian, directors of local departments of social services,  
19 directors of area agencies on aging, and the Secretary of Aging may delegate  
20 responsibilities of guardianship to staff persons whose names and positions have been  
21 registered with the court.

22                  (b)    A person specified in a priority in subsection (a)(2), (3), (5), or (6) may

29 his duty to support the disabled person, and to apply the estate to the support, care,  
30 and education of the disabled person, except that the guardian of the person may not  
31 obtain funds from the estate for room and board that the guardian, his spouse, parent,  
32 or child provide without a court order approving the charge, and the duty to exercise  
33 care to conserve any excess estate for the needs of the disabled person;

34 (6) If a guardian of the estate has been appointed, the duty to control  
35 the custody and care of the disabled person, to receive reasonable sums for room and  
36 board provided to the disabled person, and to account to the guardian of the estate for

1 funds expended, and the right to ask the guardian of the estate to expend the estate in  
2 payment of third persons for care and maintenance of the disabled person;

3           (7) The duty to file an annual report with the court indicating the  
4 present place of residence and health status of the ward, the guardian's plan for  
5 preserving and maintaining the future well-being of the ward, and the need for  
6 continuance or cessation of the guardianship or for any alteration in the powers of the  
7 guardian. The court shall renew the appointment of the guardian if it is satisfied that  
8 the grounds for the original appointment stated in § 13-705(b) above continue to exist.  
9 If the court believes such grounds may not exist, it shall hold a hearing, similar to that  
10 provided for in § 13-705 above, at which the guardian shall be required to prove that  
11 such grounds exist. If the court does not make these findings, it shall order the

15           (8) The power to give necessary consent or approval for:

16                   (i) Medical or other professional care, counsel, treatment, or  
17 service, including admission to a hospital or nursing home or transfer from one  
18 medical facility to another;

19                   (ii) Withholding medical or other professional care, counsel,  
20 treatment, or service; and

21                   (iii) Withdrawing medical or other professional care, counsel,  
22 treatment, or service.

23           (c) (1) Notwithstanding the powers conferred to a guardian under  
24 subsection (b)(8) of this section, and except as provided in paragraph (2) of this  
25 subsection, where a medical procedure involves, or would involve, a substantial risk to  
26 the life of a disabled person, the court must authorize a guardian's consent or approval  
27 for:

28                   (i) The medical procedure;

29                   (ii) Withholding the medical procedure; or

30                   (iii) Withdrawing the medical procedure that involves, or would  
31 involve, a substantial risk to the life of the disabled person.

32           (2) The court may, upon such conditions as the court considers  
33 appropriate, authorize a guardian to make a decision regarding medical procedures  
34 that involve a substantial risk to life without further court authorization, if:

35                   (i) The disabled person has executed an advance directive in  
36 accordance with Title 5, Subtitle 6 of the Health – General Article that authorizes the

1 guardian to consent to the provision, withholding or withdrawal of a medical  
2 procedure that involves a substantial risk to life but does not appoint a health care  
3 agent; or

4 (ii) The guardian is:

5 1. Within a class of individuals specified in § 5–605(a)(2)  
6 of the Health – General Article as authorized to make health care decisions for the  
7 disabled person; and

8 2. Determined by the court to be familiar with the  
9 personal beliefs, values, and medical situation of the disabled person.

10 (3) A petition seeking the authorization of a court that a  
11 life-sustaining procedure be withheld or withdrawn is subject to the provisions of §§  
12 13–711 through 13–713 of this subtitle.

13 (d) (1) Notwithstanding subsection (a) of this section, and in addition to  
14 the rights, duties, and powers which the court may order under subsection (b) of this  
15 section, the court may order the relief provided under this subsection.

16 (2) (i) If a guardian of the estate has been appointed, a guardian of  
17 the person may ask the guardian of the estate to expend the estate in payment of care  
18 and maintenance services provided directly to the disabled person by the guardian of  
19 the person at the rate of reimbursement established under this subsection.

20 (ii) The guardian of the person shall maintain appropriate  
21 records to document the care and maintenance services provided directly to the  
22 disabled person to receive any payment under this subsection.

23 (3) To implement the provisions of this subsection, the court may:

24 (i) Adopt guidelines for the rate of reimbursement for care and  
25 maintenance services provided directly by the guardian of the person to a disabled  
26 person;

27 (ii) Establish appropriate procedures for records, inspections,  
28 audits, or other requirements to monitor care and maintenance services provided  
29 directly by the guardian of the person for which the guardian of the person is  
30 reimbursed; and

31 (iii) Order any act necessary for the best interests of the disabled  
32 person.

33 13–709.

1           (a)    When, from personal observation of a law enforcement officer, it appears  
2 probable that an adult will suffer immediate and serious physical injury or death if not  
3 immediately placed in a health care facility, that the adult is incapable of giving  
4 consent, and that it is not possible to follow the procedures of this section, the officer  
5 shall transport the person to an appropriate medical facility which shall immediately  
6 notify the next of kin and the director. This medical care may not be rendered in a  
7 State mental hospital other than, in an appropriate case, the Walter P. Carter  
8 Community Mental Health and Retardation Center and the Highland Health Facility  
9 unless authorized by the courts in a civil commitment proceeding. The director shall  
10 file a petition pursuant to subsection (b) of this section within 24 hours after the

21           (c)    In issuing an emergency order, the court shall adhere to the following

23                   (1)    Only such protective services as are necessary to remove the  
24 conditions creating the emergency shall be ordered; the court shall specifically  
25 designate the approved services in its order;

26                   (2)    Protective services authorized by an emergency order shall not  
27 include hospitalization or a change of residence unless the court specifically finds such  
28 action is necessary and gives specific approval for such action in its order;

29                   (3)    Protective services may be provided under an initial emergency  
30 order for not more than 144 hours, and the initial order may be renewed as provided in  
31 paragraph (5) of this subsection;

32                   (4)    In its order the court shall appoint the petitioner, another  
33 interested person, the director, or the Secretary of Aging as temporary guardian of the  
34 person with responsibility for the person's welfare and authority to give consent for  
35 the person for the approved protective services until the expiration of the order;

36                   (5)    Notwithstanding the provisions of paragraphs (3) and (4) of this  
37 subsection, the court may extend the terms of the emergency order and the

1 appointment of the temporary guardian until appointment of a guardian of the person  
2 pursuant to § 13–705 of this subtitle, upon petition of the temporary guardian, the  
3 director, or the Secretary of Aging, as appropriate, and after a showing that the  
4 conditions found to exist in subsection (b) of this section will probably continue beyond  
5 the expiration of the extended emergency order. Such petition shall be filed before the  
6 expiration of the six–day period provided for in paragraph (3) of this subsection and  
7 shall be accompanied by a petition for appointment of a guardian of the person  
8 pursuant to § 13–705 of this subtitle. Such petition for appointment of a guardian of  
9 the person shall be heard on an expedited basis no more than 60 days after the filing  
10 of the petition;

11 (6) The issuance of an emergency order and the appointment of a  
12 temporary guardian shall not deprive the person of any rights except to the extent  
13 provided for in the order or appointment; and

14 (7) To implement an emergency order, the court may authorize  
15 forcible entry of the premises of the person for the purpose of rendering protective  
16 services or transporting the person to another location for the provision of such  
17 services only after a showing to the court that attempts to gain voluntary access to the  
18 premises have failed and forcible entry is necessary. Persons making authorized  
19 forcible entry shall be accompanied by a law enforcement officer, the director or his  
20 representative, and if appropriate, a representative of the local department of health.

21 (d) The petition for an emergency order shall set forth the name, address,  
22 and interest of the petitioner; the name, age, and address of the person in need of  
23 protective services; the nature of the person’s disability, if determinable; the proposed  
24 protective services; the petitioner’s reasonable belief, together with facts supportive  
25 thereof, as to the existence of the facts stated in subsection (b)(1) through (3) of this  
26 section; and facts showing petitioner’s attempts to obtain the person’s consent to the  
27 services and the outcomes of such attempts.

28 (e) Notice of the filing of such petition shall be given as required in the  
29 Maryland Rules and to the director. Such notice shall be given in language reasonably  
30 understandable by the intended recipients at least 24 hours prior to the hearing for  
31 emergency intervention. The court may waive the 24–hour notice requirement upon a  
32 showing that (1) immediate and reasonably foreseeable physical harm to the person or  
33 others will result from the 24–hour delay, and (2) reasonable attempts have been  
34 made to give such notice. Notice of the court’s final order shall be given to the same  
35 parties.

36 (f) (1) The hearing on a petition for an emergency order for protective  
37 services shall be held under the following conditions:

38 (i) The person shall be present unless he has knowingly and  
39 voluntarily waived the right to be present or cannot be present because of physical or  
40 mental incapacity. Waiver or incapacity may not be presumed from nonappearance

1 but shall be determined on the basis of factual information supplied to the court by  
2 counsel or a representative appointed by the court.

3 (ii) The person has the right to counsel whether or not he is  
4 present at the hearing. Subject to paragraph (2) of this subsection, if the person is  
5 indigent or lacks the capacity to waive counsel, the court shall appoint counsel. Where  
6 the person is indigent, the State shall pay reasonable attorney's fees.

7 (iii) The person may present evidence and cross-examine  
8 witnesses. This hearing shall be held no earlier than 24 hours after the notice required  
9 in subsection (e) of this section has been given, unless such notice has been waived by  
10 the court.

11 (2) In any action in which payment for the services of a  
12 court-appointed attorney for the person is the responsibility of the local department of  
13 social services, unless the court finds that it would not be in the best interests of the  
14 person, the court shall:

15 (i) Appoint an attorney who has contracted with the  
16 Department of Human Resources to provide those services, in accordance with the  
17 terms of the contract; and

18 (ii) In an action in which an attorney has previously been  
19 appointed, strike the appearance of the attorney previously appointed and appoint the  
20 attorney who is currently under contract with the Department of Human Resources, in  
21 accordance with the terms of the contract.

22 (g) The court shall issue for the record a statement of its findings in support  
23 of any order for emergency protective services.

24 (h) The person, the temporary guardian, or any interested person may  
25 petition the court to have the emergency order set aside or modified at any time,  
26 notwithstanding any prior findings by the court that the person is disabled.

27 (i) Where protective services are rendered on the basis of an emergency  
28 order, the temporary guardian shall submit a report describing the circumstances  
29 including the name, place, date, and nature of the services, and the use of forcible  
30 entry, if any, to the court and the director. This report shall become part of the court  
31 record.

32 (j) The person or the guardian of the person may appeal any findings of a  
33 court under subsection (b) of this section. Such appeal shall be handled on an  
34 expedited basis by the appellate court.

35 13-710.

1 (a) Any person filing a petition, participating in the making of a good-faith  
2 report, or participating in an investigation or in a judicial proceeding resulting  
3 therefrom, pursuant to § 13-705 or § 13-709 of this article or Title 14, Subtitle 3 of the  
4 Family Law Article, shall have the immunity from civil liability or criminal penalty  
5 described under § 5-618(a) of the Courts and Judicial Proceedings Article.

6 (b) A law enforcement officer who transports an adult to an appropriate  
7 medical facility under § 13-709 of this article shall have the immunity from civil or  
8 criminal liability described under § 5-618(b) of the Courts and Judicial Proceedings  
9 Article.

10 13-711.

11 (a) In this Part III of this subtitle the following words have the meanings  
12 indicated.

13 (b) "Best interest" means that the benefits to the disabled person resulting  
14 from a treatment outweigh the burdens to the disabled person resulting from that  
15 treatment, taking into account:

16 (1) The effect of the treatment on the physical, emotional, and  
17 cognitive functions of the disabled person;

18 (2) The degree of physical pain or discomfort caused to the disabled  
19 person by the treatment, or the withholding or withdrawal of the treatment;

20 (3) The degree to which the disabled person's medical condition, the  
21 treatment, or the withholding or withdrawal of treatment, result in a severe and  
22 continuing impairment of the dignity of the disabled person by subjecting the  
23 individual to a condition of extreme humiliation and dependency;

24 (4) The effect of the treatment on the life expectancy of the disabled  
25 person;

26 (5) The prognosis of the disabled person for recovery, with and without  
27 the treatment;

28 (6) The risks, side effects, and benefits of the treatment or the  
29 withholding or withdrawal of the treatment; and

30 (7) The religious beliefs and basic values of the disabled person  
31 receiving treatment, to the extent these may assist the decision maker in determining  
32 best interest.

33 (c) "Life-sustaining procedure" means any medical procedure, treatment, or  
34 intervention used to sustain, restore, supplement, or supplant a spontaneous vital  
35 function in order to prevent or postpone the death of a disabled person.

1 (d) “Substituted judgment” means a determination by a court that a disabled  
2 person would, if competent, make the same health care decision regarding a  
3 life-sustaining procedure taking into account any information that may be relevant to  
4 the decision, including:

5 (1) The current diagnosis, prognosis with and without the  
6 life-sustaining procedure, and life expectancy of the disabled person;

7 (2) Any expressed preferences of the disabled person regarding the  
8 provision of, or the withholding or withdrawal of, the life-sustaining procedure at  
9 issue;

10 (3) Any expressed preferences of the disabled person about the  
11 provision of, or the withholding or withdrawal of, life-sustaining procedures generally;

12 (4) Any religious or moral beliefs or personal values of the disabled  
13 person in relation to the provision of, or the withholding or withdrawal of,  
14 life-sustaining procedures;

15 (5) Any behavioral or other manifestations of the attitude of the  
16 disabled person toward the provision of, or the withholding or withdrawal of, the  
17 life-sustaining procedure;

18 (6) Any consistent pattern of conduct by the disabled person regarding  
19 prior decisions about health care;

20 (7) Any reactions of the disabled person to the provision of, or the  
21 withholding or withdrawal of, a comparable life-sustaining procedure for another  
22 individual; and

23 (8) Any expressed concerns of the disabled person about the effect on  
24 the family or intimate friends of the disabled person if a life-sustaining procedure  
25 were provided, withheld, or withdrawn.

26 13-712.

27 (a) The court may approve a request for the withholding or withdrawal of a  
28 life-sustaining procedure from a disabled person on the basis of a substituted  
29 judgment.

30 (b) The court may make a substituted judgment under subsection (a) of this  
31 section only on the basis of clear and convincing evidence that the disabled person  
32 would, if competent, decide to withhold or withdraw a life-sustaining procedure under  
33 the circumstances.



1 (c) Evidence of the intentions or wishes of the disabled person regarding the  
2 withholding or withdrawal of a life-sustaining procedure that might otherwise be  
3 inadmissible may be admitted, in the discretion of the court, if it is:

4 (1) Material and probative; and

5 (2) The best evidence available.

6 13-713.

7 (a) If the court is unable to make a substituted judgment under § 13-712 of  
8 this subtitle, the court may approve a request for the withholding or withdrawal of a  
9 life-sustaining procedure from the disabled person if the court determines, on the  
10 basis of clear and convincing evidence, that the withholding or withdrawal is in the  
11 best interest of the disabled person.

12 (b) The decision of whether life-sustaining procedures should be provided,  
13 withheld, or withdrawn shall not be based, in whole or in part, on either a patient's  
14 preexisting, long-term mental or physical disability, or a patient's economic  
15 disadvantage.

16 **TITLE 13.5. MARYLAND UNIFORM ADULT GUARDIANSHIP AND PROTECTIVE**  
17 **PROCEEDINGS JURISDICTION ACT.**

18 **SUBTITLE 1. GENERAL PROVISIONS.**

19 **13.5-101.**

20 (A) IN THIS TITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
21 INDICATED.

22 (B) "CONSERVATOR" MEANS A PERSON APPOINTED BY A COURT TO  
23 ADMINISTER THE PROPERTY OF AN ADULT, INCLUDING A PERSON APPOINTED  
24 AS GUARDIAN UNDER TITLE 13, SUBTITLE 2 OF THIS ARTICLE TO MANAGE THE  
25 PROPERTY OF A DISABLED PERSON.

26 (C) "EMERGENCY" MEANS A CIRCUMSTANCE THAT LIKELY WILL  
27 RESULT IN A SUBSTANTIAL HARM TO THE HEALTH, SAFETY, OR WELFARE OF A  
28 RESPONDENT, AND FOR WHICH THE APPOINTMENT OF A GUARDIAN IS  
29 NECESSARY BECAUSE NO OTHER PERSON HAS AUTHORITY AND IS WILLING TO  
30 ACT ON BEHALF OF THE RESPONDENT.
