10 ~~Forty-One Dollars (\$1,033,794,441)~~, the proceeds to be used for certain

14 subdivisions and other organizations for acquiring certain rights in land and

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 26 MARYLAND, That:

27 (1) The Board of Public Works may borrow money and incur indebtedness on
 28 behalf of the State of Maryland through a State loan to be known as the Maryland
 29 Consolidated Capital Bond Loan of 2010 in the total principal amount of
 30 ~~\$1,017,575,000~~ ~~\$1,031,794,000~~ \$1,033,794,441. This loan shall be evidenced by the
 31 issuance, sale, and delivery of State general obligation bonds authorized by a
 32 resolution of the Board of Public Works and issued, sold, and delivered in accordance
 33 with §§ 8–117 through 8–124 of the State Finance and Procurement Article and
 34 Article 31, § 22 of the Code.

35 (2) The bonds to evidence this loan or installments of this loan may be sold
 36 as a single issue of bonds under § 8–122 of the State Finance and Procurement Article.

37 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
 38 and first shall be applied to the payment of the expenses of issuing, selling, and

1 delivering the bonds, unless funds for this purpose are otherwise provided, and then
2 shall be credited on the books of the Comptroller and expended, on approval by the
