## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2008 – Maryland Independent**  
3 **College and University Association – Sojourner–Douglass College**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2008  
5 to extend the date by which the Board of Trustees of Sojourner–Douglass  
6 College must present evidence that a matching fund will be provided.

7 BY repealing and reenacting, with amendments,  
8 Chapter 336 of the Acts of the General Assembly of 2008, as amended by  
9 Chapter 707 of the Acts of the General Assembly of 2009  
10 Section 1(3) Item ZA00(M)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Chapter 336 of the Acts of 2008, as amended by Chapter 707 of the Acts of**  
14 **2009**

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That:

17 (3) ZA00 MISCELLANEOUS GRANT PROGRAMS

18 (M) Maryland Independent College and University Association –  
19 Sojourner–Douglass College – Science and Allied Health  
20 Facility. Provide a grant equal to the lesser of (i) \$3,250,000  
21 or (ii) the amount of the matching fund provided, to the Board  
22 of Trustees of Sojourner–Douglass College to assist in the  
23 design and construction of the expansion and renovation of a  
24 newly acquired building located at 249 N. Aisquith Street in  
25 Baltimore, subject to the requirement that the grantee

1 provide an equal and matching fund for this purpose.  
 2 Notwithstanding the provisions of Section 1(5) of this Act, the  
 3 matching fund may consist of in kind contributions or funds  
 4 expended prior to the effective date of this Act **AND THE**  
 5 **GRANTEE MUST PRESENT EVIDENCE THAT A MATCHING**  
 6 **FUND WILL BE PROVIDED BY JUNE 1, 2012** (Baltimore  
 7 City) ..... 3,250,000

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 9 June 1, 2010.
