#### AMENDMENT NO. 1

On page 1, in line 16, strike "under certain circumstances" and substitute "<u>subject to certain conditions</u>"; and in line 17, after "nonmembers;" insert "<u>requiring an</u> <u>exclusive representative</u>, if a memorandum of understanding contains a certain <u>service fee provision</u>, to provide notice of the service fee provision to independent home care providers before a certain vote is held;".

#### AMENDMENT NO. 2

On page 2, in line 19, after "ARE" insert "<u>DIRECTLY</u>"; in the same line, after "REIMBURSED" insert "<u>BY THE STATE OR A FISCAL INTERMEDIARY FUNCTIONING</u> ON BEHALF OF THE STATE, AND NOT BY AN AGENCY OR BUSINESS THAT <u>EMPLOYS EMPLOYEES OR REFERS INDEPENDENT CONTRACTORS AS HOME CARE</u> <u>PROVIDERS</u>,"; in lines 23 and 27, in each instance, after "TITLE" insert ", <u>OR ANY</u> <u>SUCCESSOR PROGRAM</u>"; in line 28, after "PROGRAM" insert ", <u>OR ANY SUCCESSOR</u> <u>PROGRAM</u>"; in line 29, after "RESOURCES" insert ", <u>OR ANY SUCCESSOR</u> <u>PROGRAM</u>"; in the same line, strike "AND"; in line 30, after "EMPLOYED" insert "<u>OR</u> <u>REFERRED</u>"; in the same line, strike "A PRIVATE" and substitute "<u>AN</u>"; in the same line, after "AGENCY" insert "<u>OR BUSINESS</u>"; in the same line, after "EMPLOYS" insert "<u>EMPLOYEES OR REFERS INDEPENDENT CONTRACTORS AS</u>"; and in line 31, after "PROVIDERS" insert ";

## (3) CONTRACTS DIRECTLY WITH A PROGRAM PARTICIPANT FOR HOME CARE SERVICES; AND

## (4) PROVIDES HOME CARE SERVICES TO A PROGRAM PARTICIPANT PERSONALLY AND DOES NOT SUBCONTRACT WITH ANY OTHER PARTY TO PROVIDE THE SERVICES TO A PROGRAM PARTICIPANT".

On page 3, in line 1, after "(C)" insert "(<u>1</u>)"; in lines 2 and 3, strike "(<u>1</u>)" and "(<u>2</u>)", respectively, and substitute "(<u>1</u>)" and "(<u>(II)</u>", respectively; and after line 4, insert:

# "(2) "PROVIDER ORGANIZATION" DOES NOT INCLUDE AN AGENCY OR BUSINESS THAT EMPLOYS EMPLOYEES OR REFERS INDEPENDENT CONTRACTORS AS HOME CARE PROVIDERS.".

### AMENDMENT NO. 3

On page 4, in line 29, strike "SUBPARAGRAPH (II)" and substitute "SUBPARAGRAPHS (II) AND (III)".

On page 5, after line 6, insert:

"(III) THE REPRESENTATIVES OF THE STATE MAY ONLY AGREE TO A SERVICE FEE PROVISION IF THE SERVICE FEE PROVISION WOULD REQUIRE NONMEMBERS TO PAY SERVICE FEES ON A SLIDING SCALE IN APPROXIMATE PROPORTION TO THE AMOUNT EACH NONMEMBER RECEIVES IN REIMBURSEMENT THROUGH:

1. <u>THE MEDICAID WAIVER FOR OLDER ADULTS</u> <u>THAT IS JOINTLY ADMINISTERED BY THE DEPARTMENT AND THE DEPARTMENT</u> OF AGING AS ESTABLISHED UNDER § 15-132 OF THIS TITLE, OR ANY SUCCESSOR <u>PROGRAM;</u>

in line 27, after "(G)" insert "(1)"; and after line 29, insert:

# "(2) IF THE MEMORANDUM OF UNDERSTANDING CONTAINS A SERVICE FEE PROVISION, BEFORE THE VOTE TO RATIFY THE MEMORANDUM OF UNDERSTANDING IS HELD, THE EXCLUSIVE REPRESENTATIVE SHALL PROVIDE NOTICE THAT THE MEMORANDUM OF UNDERSTANDING CONTAINS A PROVISION FOR A SERVICE FEE THAT WILL BE CHARGED ON A SLIDING SCALE TO INDEPENDENT HOME CARE PROVIDERS.".

### AMENDMENT NO. 4

On page 6, in line 34, strike "Economic Matters" and substitute "<u>Appropriations</u>".
