AMENDMENT NO. 1

On page 1, strike beginning with "authorizing" in line 3 down through "establish" in line 4 and substitute "<u>altering</u>"; in line 5, strike "for acting as a cigarette retailer, for selling cigarettes at retail,"; and in line 14, strike "16-204(b)(1), 16-302,".

AMENDMENT NO. 2

On pages 1 and 2, strike in their entirety the lines beginning with line 21 on page 1 through line 17 on page 2, inclusive.

On page 2, in line 22, strike the brackets; and strike beginning with "; OR" in line 23 down through "COUNTY" in line 26.

AMENDMENT NO. 3

On page 3, in lines 5, 16, and 25, in each instance, after "City" insert "<u>OR</u> <u>BALTIMORE COUNTY</u>"; in lines 5, 14, 16, and 23, in each instance, strike the brackets; strike beginning with "; OR" in line 6 down through "COUNTY" in line 9; strike beginning with "OR" in line 16 down through "; AND" in line 19; and strike beginning with "; OR" in line 25 down through "COUNTY" in line 28.

On page 4, in line 17, after "City" insert "<u>OR BALTIMORE COUNTY</u>"; and strike in their entirety lines 19 through 22, inclusive.

On page 5, in lines 6 and 22, in each instance, after "City" insert "<u>OR</u> <u>BALTIMORE COUNTY</u>"; strike in their entirety lines 10 through 12, inclusive; in line 23, strike "(1)"; and strike in their entirety lines 25 through 27, inclusive.

AMENDMENT NO. 6
