"<u>BY repealing and reenacting, with amendments,</u> <u>Article - Corporations and Associations</u> Section 1-502(a) and (b) and 5-6C-03

<u>Annotated Code of Maryland</u> (2007 Replacement Volume and 2010 Supplement)".

[(1)] (I) "Company", if it is not preceded by the word "and" or a symbol for the word "and";

- [(2)] (II) <u>"Corporation";</u>
- [(3)] (III) "Incorporated"; or
- [(4)] (IV) "Limited".

(2) IF A CORPORATION IS A BENEFIT CORPORATION, THE NAME OF THE BENEFIT CORPORATION MUST INCLUDE:

- (I) <u>THE WORDS "BENEFIT CORPORATION"</u>;
- (II) <u>"BENEFIT CORP.";</u>

(III) <u>THE WORDS "BENEFIT COMPANY", IF NOT PRECEDED BY</u> <u>THE WORD "AND" OR A SYMBOL FOR THE WORD "AND"; OR</u>

(IV) <u>"BENEFIT CO.", IF NOT PRECEDED BY THE WORD "AND"</u> OR A SYMBOL FOR THE WORD "AND".

- (b) (1) The name of a limited liability company must include:
 - [(1)] (I) <u>The words "limited liability company";</u>
 - [(2)] (II) <u>"L.L.C.";</u>

- [(3)] (III) <u>"LLC";</u>
- [(4)] (IV) <u>"L.C."; or</u>
- [(5)] (V) <u>"LC"</u>.

(2) IF A LIMITED LIABILITY COMPANY IS A BENEFIT LIMITED LIABILITY COMPANY, THE NAME OF THE BENEFIT LIMITED LIABILITY COMPANY MUST INCLUDE:

- (I) <u>THE WORDS "BENEFIT LIMITED LIABILITY COMPANY";</u>
- (II) <u>"BENEFIT L.L.C.";</u>
- (III) <u>"BENEFIT LLC";</u>
