AMENDMENTS TO SENATE BILL 875

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “Executive” in line 2 down through “County” in line 3; strike beginning with “repealing” in line 4 down through “regulating” in line 8 and substitute “altering”; in line 9, after “County” insert “; and generally relating to alcoholic beverages license fees in Baltimore County”; in line 13, strike “6-702(b),”; in lines 14 and 15, strike “8-404.1(a), (b), and (c)”; in line 21, strike “6-702(g),”; in line 22, strike “8-404.1(d), 8-601,”; and in line 27, strike “and 18-105”.

AMENDMENT NO. 2

On page 2, strike beginning with “SHALL” in line 8 down through “ARTICLE” in line 9 and substitute “IS \$100”; strike beginning with “SHALL” in line 17 down through “ARTICLE” in line 18 and substitute “IS \$250”; and strike beginning with “SHALL” in line 24 down through “ARTICLE” in line 25 and substitute “IS \$300”.

AMENDMENT NO. 3

On page 3, strike beginning with “SHALL” in line 1 down through “ARTICLE” in line 2 and substitute “IS \$150”; strike beginning with “SHALL” in line 9 down through “ARTICLE” in line 10 and substitute “IS \$250”; strike beginning with “SHALL” in line 18 down through “ARTICLE” in line 19 and substitute “IS \$900”; strike beginning with “SHALL” in line 26 down through “ARTICLE” in line 27 and substitute “IS \$1,500”; and strike beginning with “SHALL” in line 34 down through “ARTICLE” in line 35 and substitute “IS \$1,000”.

AMENDMENT NO. 4

On page 4, strike beginning with “SHALL” in line 7 down through “ARTICLE” in line 8 and substitute “**IS \$1,500**”; strike in their entirety lines 9 through 16, inclusive; in line 24, strike the bracket; in the same line, strike “\$10” and substitute “**\$30**”; strike beginning with the bracket in line 26 down through “ARTICLE” in line 27 and substitute “**\$20**”; in line 34, strike the bracket; and in the same line, strike “\$25” and substitute “**\$50**”.

AMENDMENT NO. 5

On page 5, strike beginning with “\$15” in line 1 down through “ARTICLE” in line 2 and substitute “**\$35**”; strike beginning with “SHALL” in line 17 down through “ARTICLE” in line 18 and substitute “**\$2,000**”; and strike beginning with “SHALL” in line 26 down through “ARTICLE” in line 27 and substitute “**IS \$2,000**”.

AMENDMENT NO. 6

On page 6, strike beginning with “SHALL” in line 1 down through “ARTICLE” in line 2 and substitute “**IS \$60**”; in line 6, strike the brackets; in the same line, strike “\$15” and substitute “**\$30**”; and strike beginning with “SHALL” in line 6 down through “ARTICLE” in line 7.

AMENDMENT NO. 7

On pages 6 and 7, strike in their entirety the lines beginning with line 8 on page 6 through line 12 on page 7, inclusive.

On page 7, in line 16, strike the brackets; in the same line, strike “\$15” and substitute “**\$50**”; and strike beginning with “SHALL” in line 16 down through “COUNTY” in line 21.
