AMENDMENT NO. 1

On page 1, strike beginning with "authorizing" in line 3 down through "establish" in line 4 and substitute "<u>altering</u>"; in line 5, strike "for acting as a cigarette retailer, for selling cigarettes at retail,"; and in line 14, strike "16-204(b)(1), 16-302,".

AMENDMENT NO. 2

AMENDMENT NO. 6

On page 6, in line 5, after "City" insert ", BALTIMORE COUNTY,"; in line 7, strike the brackets; and strike beginning with "EXCEPT" in line 8 down through "COUNTY" in line 12.
