AMENDMENTS TO SENATE BILL 167
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “, other” in line 3 down through “individuals,” in line 4; in line 7, after “regarding” insert “certain”; in the same line, after “withholding” insert “or filing at certain times and evidencing certain payment; requiring certain information collected as part of certain students’ registration to remain confidential”; and in line 8, after “policies;” insert “defining a certain term;”.

AMENDMENT NO. 2

On page 1, after line 19, insert:

“(A) IN THIS SECTION, “INDIVIDUAL”:

(1) INCLUDES AN UNDOCUMENTED IMMIGRANT INDIVIDUAL; AND

(2) DOES NOT INCLUDE A NONIMMIGRANT ALIEN WITHIN THE MEANING OF 8 U.S.C. § 1101(A)(15).”;

in line 20, strike “(A)” and substitute “(B)”; strike beginning with “, OTHER” in line 21 down through the comma in line 22; in line 22, strike “NONRESIDENT” and substitute “OUT-OF-STATE”; in line 23, after “AT” insert “:

(1) A COMMUNITY COLLEGE IN THE STATE,”;

and strike beginning with “A” in line 23 down through “RESIDENCY” in line 24.

(Over)

On page 2, in lines 1, 3, 6, 9, 14, and 19, strike “(1)”, “(2)”, “(3)”, “(4)”, “(5)”, and “(6)”, respectively, and substitute “(I)”, “(II)”, “(III)”, “(IV)”, “(V)”, and “(VI)”, respectively; in line 1, strike “ATTENDED” and substitute “BEGINNING WITH THE 2005 - 2006 SCHOOL YEAR, ATTENDED”; in lines 2, 4, 5, 7, 20, 22, and 23, in each instance, strike “THIS” and substitute “THE”; in line 3, strike “GRADUATED” and substitute “BEGINNING WITH THE 2007 - 2008 SCHOOL YEAR, GRADUATED”; in lines 6 and 7, strike “PUBLIC INSTITUTION OF HIGHER EDUCATION” and substitute “COMMUNITY COLLEGE”; in lines 9 and 10, strike “PUBLIC INSTITUTION OF HIGHER EDUCATION” and substitute “COMMUNITY COLLEGE”; in line 11, after “WITHHELD” insert “OR HAS FILED A MARYLAND INCOME TAX RETURN:”

1. WHILE THE INDIVIDUAL ATTENDED A PUBLIC OR NONPUBLIC SECONDARY SCHOOL IN THE STATE;

2. SUBJECT TO ITEM (VI) OF THIS PARAGRAPH, ANNUALLY SINCE GRADUATING FROM A PUBLIC OR NONPUBLIC SECONDARY SCHOOL IN THE STATE AND BEFORE REGISTRATION AT A COMMUNITY COLLEGE IN THE STATE; AND

3. DURING THE PERIOD OF ATTENDANCE AT THE COMMUNITY COLLEGE”;

strike beginning with “DURING” in line 11 down through “STATE” in line 13; in line 15, strike “PUBLIC INSTITUTION OF HIGHER EDUCATION” and substitute “COMMUNITY COLLEGE”; strike beginning with “MAKES” in line 19 down through “EDUCATION” in line 20 and substitute “REGISTERS IN A COMMUNITY COLLEGE”; in line 20, strike “3” and substitute “4”; in line 23, after “STATE” insert “; OR”

(2) A PUBLIC SENIOR HIGHER EDUCATION INSTITUTION, IF THE INDIVIDUAL:

(I) ATTENDED A COMMUNITY COLLEGE UNDER THE REQUIREMENTS OF PARAGRAPH (1) OF THIS SUBSECTION;

(II) WAS AWARDED AN ASSOCIATE'S DEGREE BY OR ACHIEVED 60 CREDITS AT A COMMUNITY COLLEGE IN THE STATE;

(III) PROVIDES THE PUBLIC SENIOR HIGHER EDUCATION INSTITUTION A COPY OF THE AFFIDAVIT SUBMITTED UNDER PARAGRAPH (1)(V) OF THIS SUBSECTION;

(IV) PROVIDES TO THE PUBLIC SENIOR HIGHER EDUCATION INSTITUTION DOCUMENTATION THAT THE INDIVIDUAL OR THE INDIVIDUAL'S PARENT OR GUARDIAN HAS HAD MARYLAND INCOME TAX WITHHELD OR HAS FILED A MARYLAND INCOME TAX RETURN;

1. WHILE THE INDIVIDUAL ATTENDED A COMMUNITY COLLEGE IN THE STATE;

2. SUBJECT TO ITEM (V) OF THIS PARAGRAPH, ANNUALLY SINCE GRADUATING FROM A COMMUNITY COLLEGE IN THE STATE AND BEFORE REGISTRATION AT A PUBLIC SENIOR HIGHER EDUCATION INSTITUTION IN THE STATE; AND

3. DURING THE PERIOD OF ATTENDANCE AT THE PUBLIC SENIOR HIGHER EDUCATION INSTITUTION; AND

(V) REGISTERS AT A PUBLIC SENIOR HIGHER EDUCATION INSTITUTION IN THE STATE NOT LATER THAN 4 YEARS AFTER GRADUATING FROM A COMMUNITY COLLEGE IN THE STATE”;

after line 23, insert:

“(C) INFORMATION COLLECTED UNDER THIS SECTION AS PART OF A STUDENT’S REGISTRATION SHALL REMAIN CONFIDENTIAL.”;

and in line 24, strike “(B)” and substitute “(D)”.
