# 2 Video Lottery Operation Licenses – Information on Payouts

3 FOR the purpose of requiring that regulations adopted by the State Lottery 4 Commission include provisions that require certain payouts above certain  $\mathbf{5}$ amounts be reported to the State Lottery Agency in a report that contains 6 certain information; requiring that the State Lottery Agency modify the report  $\mathbf{7}$ in a certain manner and forward the modified report to the Department of Human Resources' Child Support Enforcement Administration for certain 8 9 purposes; and generally relating to video lottery terminal payouts and the 10 holding of a video lottery operation license.

1 **[**(6)**] (7)** provide consumers with a record of video lottery terminal  $\mathbf{2}$ spending levels if marketing measures are utilized that track consumer spending at 3 video lottery facilities; 4 **[**(7)**] (8)** prohibit consumers from cashing paychecks at video lottery facilities: and  $\mathbf{5}$ 6 prohibit video lottery operation licensees from engaging in or **[**(8)**] (9)** 7 contracting with another to engage in predatory marketing practices. 8 **ON RECEIPT OF THE REPORT REQUIRED UNDER SUBSECTION** (G) (1) 9 (F)(3) OF THIS SECTION, THE STATE LOTTERY AGENCY SHALL MODIFY THE REPORT TO INCLUDE ONLY THE NAMES OF INDIVIDUALS WHO HAVE BEEN 10 CERTIFIED TO THE STATE LOTTERY AGENCY BY THE CHILD SUPPORT 11 12ENFORCEMENT ADMINISTRATION OF THE DEPARTMENT OF HUMAN 13**RESOURCES AS OBLIGORS WHO ARE IN ARREARS OF THEIR CHILD SUPPORT** 14**ORDERS.** 15(2) THE STATE LOTTERY AGENCY SHALL FORWARD THE MODIFIED REPORT TO THE CHILD SUPPORT ENFORCEMENT ADMINISTRATION 16 17OF THE DEPARTMENT OF HUMAN RESOURCES FOR THE PURPOSE OF ENFORCING CHILD SUPPORT ORDERS ISSUED IN ACCORDANCE WITH THE 18 APPLICABLE PROVISIONS OF THE FAMILY LAW ARTICLE. 19

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 October 1, 2011.
