Article - Health Occupations

Subject to the evaluation and reestablishment provisions of the Maryland Program Evaluation Act, and subject to the termination of this title under § 8–802 of this title, this subtitle and all rules and regulations adopted under this subtitle shall terminate and be of no effect after July 1, [2013] **2023**.

- 11 (a) On or before December 15 of the 2nd year before the evaluation date of a 12 governmental activity or unit, the Legislative Policy Committee, based on a 13 preliminary evaluation, may waive as unnecessary the evaluation required under this 14 section.

- SECTION 2. AND BE IT FURTHER ENACTED, That, on or before October 1, 22 2011, the State Board of Nursing shall submit a report to the Senate Education, Health, and Environmental Affairs Committee and the House Health and Government
- Operations Committee, in accordance with § 2–1246 of the State Government Article,
- 25 regarding how the Board has addressed:
- 26 (1) examination issues relating to obtaining initial licensure as an electrologist in the State, including the current lack of a viable examination and the authority of the Board to administer a State law section of an examination;
- 29 (2) implementation of biennial licensure renewal for electrologists;
- 30 (3) improvement of the training of and communication with members 31 of the Electrology Practice Committee;
- 32 (4) updating the Board's Web site to include a description of the 33 complaint process with respect to electrologists and a complaint form;

1 2 3	(5) reconciling the difference between fee revenues generated from electrologist licensees and the reported actual cost of the Board to regulate electrologists; and								
4 5	(6) fee revenue surplus, if any, and any plans to alter electrologist licensure fees as a result.								
6	SECTION 3. AND BE IT FURTHER ENACTED, That, on or before October 1,								
7	2015, the State Board of Nursing shall submit a report to the Senate Education,								
8	Health, and Environmental Affairs Committee and the House Health and Government								
9	Operations Committee, in accordance with § 2–1246 of the State Government Article,								
10	regarding the status of the Electrology Practice Committee and the regulation of								
11	electrology in the State. The report shall include information for the years fiscal 2011								
12	through fiscal 2015, inclusive, that addresses:								
13	(1) the number of electrologists licensed by the Board;								
14	(2) the number of complaints related to the practice of electrology								
15	received by the Board, if any, and the disposition of such complaints; and								
16	(3) a summary of any major legislative or regulatory changes								
17	impacting electrology, including changes to fees charged by the Board.								
18	SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect								
19	July 1, 2011.
