16 17	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

20 21 22	(c) (1) Any resident of this State who is [retired from] OUT OF the work force by reason of total and permanent disability who enrolls at a community college in a class that has at least 10 regularly enrolled students:
23 24	(i) Is exempt from payment of tuition FOR UP TO 6 CREDITS PER SEMESTER OR UP TO 12 CREDITS PER SEMESTER IF THE INDIVIDUAL IS

- 1 ENROLLED IN CLASSES AS PART OF A DEGREE OR A CERTIFICATE PROGRAM
 2 DESIGNED TO LEAD TO EMPLOYMENT; and
- 3 (ii) Shall be counted in computing full—time equivalent 4 enrollment under $\S 16-305$ of this title.
- 5 (2) In order to receive this exemption, an individual who meets the 6 requirements of paragraph (1) of this subsection shall [obtain] PROVIDE THE 7 COMMUNITY COLLEGE WITH certification from the Social Security Administration 8 [or], the Railroad Retirement Board [that the individual receives disability or 9 retirement benefits under the Social Security Act or the Railroad Retirement Act.
- 10 (3) In order to obtain this exemption, an individual who meets the 11 requirements of paragraph (1) of this subsection, who was a federal employee, and who 12 does not receive disability or retirement benefits under the Social Security Act or the 13 Railroad Retirement Act shall obtain certification from], OR IN THE CASE OF A 14 FORMER FEDERAL EMPLOYEE, FROM the individual's federal retirement or pension 15 authority of the [employee's] INDIVIDUAL'S:
- 16 (i) Total and permanent disability; and
- 17 (ii) Receipt of disability **OR RETIREMENT** benefits based on a standard that is at least as stringent as the standard applied by the Social Security 19 Act.
 - **(4)** CERTIFICATION **FROM** SOCIAL SECURITY THE ADMINISTRATION ANINDIVIDUAL'S \mathbf{OF} **DISABILITY** OF RECEIPT RETIREMENT BENEFITS UNDER EITHER TITLE II OR TITLE XVI OF THE FEDERAL SOCIAL SECURITY ACT SHALL SATISFY THE REQUIREMENT IN PARAGRAPH (3)(II) OF THIS SUBSECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2011.
