of the Interagency Committee on School Construction, to adopt certain
regulations; providing for the application of this Act; providing for the
termination of this Act; and generally relating to public school construction.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 (b) (1) For the purposes of this section other than subsection (c), the 20 Board of Public Works shall define by regulation what constitutes an eligible and 21 ineligible public school construction or capital improvement cost.
- 22 (2) (i) The Board of Public Works shall include modular 23 construction as an approved public school construction or capital **IMPROVEMENT** cost.
