## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2009 – Prince George’s County**  
3 **– Olde Mill Community and Teaching Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2009  
5 to extend the deadline for the Board of Directors of the Olde Mill Foundation,  
6 Inc. to present evidence that a matching fund will be provided; requiring that  
7 the Board of Public Works expend or encumber the proceeds of the loan by June  
8 1, 2013; and generally relating to amending the Maryland Consolidated Capital  
9 Bond Loan of 2009.

10 BY repealing and reenacting, with amendments,  
11 Chapter 485 of the Acts of the General Assembly of 2009  
12 Section 1(3) Item ZA03(BG)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

### 15 **Chapter 485 of the Acts of 2009**

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That:

18 (3) ZA03 LOCAL SENATE INITIATIVES

19 (BG) Olde Mill Community and Teaching Center. Provide a grant  
20 equal to the lesser of (i) \$25,000 or (ii) the amount of the  
21 matching fund provided, to the Board of Directors of the Olde  
22 Mill Foundation, Inc. for the design and renovation of the  
23 Olde Mill Community and Teaching Center, located in Upper  
24 Marlboro. Notwithstanding Section 1(5) of this Act, the  
25 matching fund may consist of real property, **AND THE**

1           GRANTEE HAS UNTIL **JUNE 1, 2013**, TO PRESENT  
 2           EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED.  
 3           NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THE  
 4           PROCEEDS OF THE LOAN MUST BE EXPENDED OR  
 5           ENCUMBERED BY THE BOARD OF PUBLIC WORKS FOR  
 6           THE PURPOSES PROVIDED IN THIS ACT NO LATER THAN  
 7           **JUNE 1, 2013** (Prince George’s County) ..... 25,000

8           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 9           June 1, 2011.
