A BILL ENTITLED

1 AN ACT concerning

2 **Business Occupations and Professions – State Board of Plumbing –**
3 **Membership**

4 FOR the purpose of altering the membership of the State Board of Plumbing to require
5 that one member be from the area that consists of Carroll and Howard counties
6 and one member be from the area that consists of Cecil and Harford counties;
7 and generally relating to the membership of the State Board of Plumbing.

8 BY repealing and reenacting, with amendments,
9 Article – Business Occupations and Professions
10 Section 12–202(a)
11 Annotated Code of Maryland
12 (2010 Replacement Volume)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Business Occupations and Professions**

16 12–202.

- 17 (a) (1) The Board consists of 9 members.
- 18 (2) Of the 9 members of the Board:
- 19 (i) 7 shall be plumbers; and
- 20 (ii) 2 shall be consumer members.
- 21 (3) Of the 7 plumber members of the Board:

[Brackets] indicate matter deleted from existing law.



1 (i) at least 6 shall be master plumbers; and

2 (ii) 1 may be a journey plumber or a master plumber.

3 (4) Subject to paragraph (6) of this subsection, of the 7 plumber
4 members of the Board:

5 (i) 2 shall be from Baltimore City;

6 (ii) 1 shall be from the area that consists of Anne Arundel,
7 Calvert, Charles, Prince George's, and St. Mary's counties;

8 (iii) 1 shall be from the area that consists of Caroline,
9 Dorchester, Kent, Queen Anne's, Somerset, Talbot, Wicomico, and Worcester counties;

10 (iv) 1 shall be from the area that consists of Allegany, Frederick,
11 Garrett, Montgomery, and Washington counties; [and]

12 (v) [2] 1 shall be from the area that consists of Carroll[, Cecil,
13 Harford,] and Howard counties; AND

14 (VI) 1 SHALL BE FROM THE AREA THAT CONSISTS OF CECIL
15 AND HARFORD COUNTIES.

16 (5) A consumer member may not reside in the same county as a
17 plumber member.

18 (6) A member may not reside in a county or area of a county that is
19 exempted from this title.

20 (7) The Governor shall appoint the members with the advice of the
21 Secretary and with the advice and consent of the Senate.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2011.
