## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Montgomery County –**  
3 **Damascus Heritage Museum**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007  
5 to allow the authorized uses of a certain grant to include construction, repair,  
6 renovation, reconstruction, and capital equipping; extending the deadline for  
7 the Board of Directors of the Damascus Heritage Society, Inc. to present  
8 evidence that a matching fund will be provided; and generally relating to  
9 amending the Maryland Consolidated Capital Bond Loan of 2007.

10 BY repealing and reenacting, with amendments,  
11 Chapter 488 of the Acts of the General Assembly of 2007, as amended by  
12 Chapter 707 of the Acts of the General Assembly of 2009

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

1           Damascus, subject to a requirement that the grantee provide  
2           and expend a matching fund of \$100,000. Notwithstanding  
3           Section 1(5) of this Act, the matching fund may consist of in  
4           kind contributions. Notwithstanding Section 1(5) of this Act,  
5           the grantee has until June 1, **[2011] 2013**, to present  
6           evidence that a matching fund will be provided (Montgomery  
7           County) ..... 200,000

8           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
9           June 1, 2011.
