## A BILL ENTITLED

1 AN ACT concerning

### 2 St. Mary's County – Alcoholic Beverages – Beer Festival License

- 3 FOR the purpose of authorizing the Alcoholic Beverage Board of St. Mary's County to issue a special beer festival (BF) license; establishing certain requirements for 4  $\mathbf{5}$ license applicants and for holders of special beer festival licenses; establishing a 6 certain fee; specifying that a licensee is not prohibited from holding a certain 7other license; requiring the Alcoholic Beverage Board to approve the time and 8 location of a beer festival subject to certain limitations and to ensure a certain primary focus for a beer festival; requiring the Alcoholic Beverage Board to 9 adopt certain regulations; and generally relating to beer festivals in St. Mary's 10 11 County.

23 (B) NOTWITHSTANDING ANY OTHER LAW, AN APPLICANT FOR A SPECIAL 24 BF LICENSE SHALL BE A HOLDER OF AN EXISTING RETAIL ALCOHOLIC
