- 2 (A) THIS SECTION APPLIES ONLY IN FREDERICK COUNTY.
- 3 (B) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A BEER, WINE 4 AND LIQUOR TASTING (BWLT) LICENSE.
- 5 (C) A BEER, WINE AND LIQUOR TASTING LICENSE MAY BE ISSUED ONLY TO A HOLDER OF A BEER, WINE AND LIQUOR LICENSE.
- 7 (D) A BEER, WINE AND LIQUOR TASTING LICENSE AUTHORIZES THE 8 CONSUMPTION OF ONE-HALF AN OUNCE OF LIQUOR FROM A GIVEN BRAND AND 9 1.5 OUNCES FROM ALL BRANDS BY ANY ONE PERSON IN A SINGLE DAY FOR TASTING AND SAMPLING PURPOSES ONLY.
- 11 (E) THE LIMITATIONS ON THE CONSUMPTION OF BEER AND WINE 12 UNDER § 8–406 OF THIS SUBTITLE APPLY TO A BEER, WINE AND LIQUOR 13 TASTING LICENSE.
