1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 2 MARYLAND, That the Laws of Maryland read as follows:

(A) A PERSON MAY NOT:

- 16 (a) Except as otherwise specifically provided in this title, a person who violates any provision of this title is guilty of a misdemeanor and, upon conviction, is subject to a fine not exceeding \$1,000, with costs imposed in the discretion of the court.
 - (b) Unless another penalty is specifically provided elsewhere in this title, any person found guilty of a second or subsequent violation of any provision of this title is subject to a fine not exceeding \$2,000, or imprisonment not exceeding one year, or both, with costs imposed in the discretion of the court. For the purpose of this subsection, a second or subsequent violation is one which has occurred within two years of any prior violation of this title.
- 25 IN ADDITION TO ANY OTHER APPLICABLE PENALTY UNDER THIS 26 TITLE, A PERSON WHO VIOLATES § 4-708(A)(1) OF THIS TITLE (COMMITTING 27 SEPARATE COMMERCIAL **FISHING** VIOLATION WHILE LICENSE OR 28AUTHORIZATION IS SUSPENDED OR REVOKED) OR § 4–708(A)(2) OF THIS TITLE 29 (ENGAGING IN COMMERCIAL FISHING ACTIVITY WITHOUT APPROPRIATE LICENSE OR AUTHORIZATION) IS GUILTY OF A MISDEMEANOR 30 AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 1 YEAR 31 32 OR A FINE NOT EXCEEDING \$25,000 OR BOTH, WITH COSTS IMPOSED IN THE 33 DISCRETION OF THE COURT.

- (2) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A FINE IMPOSED BY THE DISTRICT COURT UNDER § 4–1201(H) OF THIS SUBTITLE ON A PERSON WHO COMMITS A SEPARATE COMMERCIAL FISHING VIOLATION WHILE THE LICENSE OR AUTHORIZATION IS SUSPENDED OR REVOKED OR WHO ENGAGES IN COMMERCIAL FISHING ACTIVITY WITHOUT HOLDING THE APPROPRIATE LICENSE OR AUTHORIZATION, LESS THE COSTS OF COLLECTION, SHALL BE PAID TO THE FISHERIES RESEARCH AND DEVELOPMENT FUND.
- 12 (b) If any fine is imposed by the circuit court of any county, the fine, less the costs of collection, shall be paid to the Fisheries Research and Development Fund, unless otherwise provided for.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2011.
