It authorizes the holder to keep for sale and sell 32 all alcoholic beverages at retail at any club, at the place described in the license, for 33 consumption on the premises only.
 - (e) In Baltimore County the annual license fee [is \$500] SHALL BE ESTABLISHED AS PROVIDED IN § 18–105 OF THIS ARTICLE.

- 2 (a) (1) A Class D beer, wine and liquor license shall be issued by the license issuing authority of the county in which the place of business is located. It authorizes the holder to keep for sale and sell all alcoholic beverages at retail at the place described in it, for consumption on the premises or elsewhere. A license may not be issued for any drugstore.
- 7 (e) (2) The annual license fee [is \$1,000] SHALL BE ESTABLISHED AS 8 PROVIDED IN § 18–105 OF THIS ARTICLE.

- 10 (b) In this section "caterer" means a Class B or Class D on—sale beer, wine 11 and liquor licensee who contracts to provide food and sell alcoholic beverages to 12 sponsors of public or private events held off the premises.
