FOR the purpose of altering the number of members of the Commission on African
American History and Culture; altering the duties of the Commission;
specifying the terms of certain members of the Commission; and generally
relating to the Commission on African American History and Culture.

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That the Laws of Maryland read as follows:

- 14 (2) four members in 2014; and
- 15 (3) four members in 2015.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2011.
