14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That:

- 16 (a) There is a Commission to Study the Impact of Immigrants in Maryland.

- 18 (1) two members of the Senate of Maryland, appointed by the19 President of the Senate;
- 20 (2) two members of the House of Delegates, appointed by the Speaker 21 of the House;

AND BE IT FURTHER ENACTED, That this Act shall take effect 1516 June 1, 2008. It shall remain effective for a period of [3] 4 years and, at the end of May 31, [2011] **2012**, with no further action required by the General Assembly, this 17Act shall be abrogated and of no further force and effect. 18

19SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect20June 1, 2011.
