program to include certain incentives for certain purposes; requiring a certain
report to the Governor and the General Assembly by a certain date; and
generally relating to a demand response pilot program for charging electric
vehicles.

20 (M) (1) ON OR BEFORE JUNE 30, 2013, BY REGULATION OR ORDER, 21 THE COMMISSION SHALL ESTABLISH A DEMAND RESPONSE PILOT PROGRAM 22 FOR ELECTRIC CUSTOMERS TO RECHARGE ELECTRIC VEHICLES DURING 23 OFF-PEAK HOURS.
