1 AN ACT concerning

2 Washington County – Alcoholic Beverages – Wine Festival License

3 FOR the purpose of establishing a special wine festival (WF) license in Washington 4 County; requiring that an applicant for a special WF license must be a holder of $\mathbf{5}$ a certain other license; specifying that a holder of a special WF license may 6 display and sell wine in a certain manner; requiring the Washington County 7Board of License Commissioners to assure that the primary focus of the Festival 8 is the promotion of Maryland wine; requiring a holder of a special WF license to 9 display and sell certain wine; providing for a license fee; providing that this Act 10 does not prohibit the holder of a special WF license from holding another 11 alcoholic beverages license; authorizing the Board to choose certain weekends for festivals; requiring the Board to choose certain locations for the festivals; 12requiring the Board to adopt certain regulations; defining certain terms; and 13 generally relating to wine in Washington County. 14

1 (H) THIS SECTION DOES NOT PROHIBIT THE HOLDER OF A SPECIAL WF 2 LICENSE FROM HOLDING ANOTHER ALCOHOLIC BEVERAGES LICENSE OF A 3 DIFFERENT CLASS OR NATURE.

4 (I) THE BOARD MAY CHOOSE 2 WEEKENDS ANNUALLY FOR THE 5 FESTIVALS.

6 (J) THE BOARD SHALL CHOOSE LOCATIONS IN THE COUNTY FOR THE 7 FESTIVALS THAT ARE NOT LICENSED UNDER THIS ARTICLE.

8 (K) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS 9 SECTION.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 July 1, 2011.
