3 **Renewal**

4 FOR the purpose of prohibiting the State Board of Plumbing from renewing ~~an~~ certain  
5 apprentice plumber ~~license~~ licenses or apprentice natural gas fitters ~~license~~  
6 licenses for more than a certain number of consecutive terms under certain  
7 circumstances ~~and subject to certain exceptions; authorizing the Board to deny,~~  
8 ~~suspend, or revoke certain licenses or reprimand certain licensees for failure to~~  
9 ~~take or register to take certain examinations within a certain period of time;~~  
10 and generally relating to the license renewal of apprentice plumbers and  
11 apprentice natural gas fitters.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
6 MARYLAND, That the Laws of Maryland read as follows:

7 **Article – Business Occupations and Professions**

8 12–101.

9 (b) “Apprentice natural gas fitter” means, unless the context requires  
10 otherwise, an individual who is licensed by the Board to assist a master natural gas  
11 fitter in providing natural gas services while:

12 (1) under the direction and control of the master natural gas fitter;  
13 and

14 (2) in training to become a journeyman natural gas fitter.

15 (c) “Apprentice plumber” means, unless the context requires otherwise, an  
16 individual who is licensed by the Board to assist a master plumber or a holder of a  
17 limited master plumber license in providing plumbing services while:

18 (1) under the direction and control of the master plumber or holder of  
19 the limited master plumber license; and

20 (2) in training to become a journey plumber.

22 (c) While an apprentice plumber license is in effect, it authorizes the licensee  
23 to assist in providing plumbing services only under the direction and control of a  
24 master plumber or a holder of a limited master plumber license.

25 (g) While an apprentice natural gas fitters license is in effect, it authorizes  
26 the licensee to provide natural gas service only under the direction and control of a  
27 licensed master natural gas fitter.

29 (a) [Unless] **SUBJECT TO § 12–308.1 OF THIS SUBTITLE, UNLESS** a  
30 license is renewed for a 2–year term as provided in this section, the license expires on  
31 the first May 1 that comes:

32 (1) after the effective date of the license; and

(2) in an odd-numbered year.

(A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION ~~AND SUBJECT TO § 12-313 OF THIS SUBTITLE, FOR AN APPRENTICE PLUMBER OR APPRENTICE NATURAL GAS FITTER ISSUED AN INITIAL LICENSE ON OR AFTER OCTOBER 1, 2011, THE BOARD MAY NOT RENEW AN APPRENTICE PLUMBER LICENSE OR APPRENTICE NATURAL GAS FITTERS~~ THE LICENSE FOR MORE THAN THREE CONSECUTIVE TERMS IF THE LICENSEE HAS NOT TAKEN OR REGISTERED TO TAKE A JOURNEY PLUMBER EXAMINATION OR JOURNEYMAN GAS FITTERS EXAMINATION.

(B) NOTWITHSTANDING SUBSECTION (A) OF THIS SECTION, IF AN APPRENTICE PLUMBER OR APPRENTICE NATURAL GAS FITTER FAILS A JOURNEY PLUMBER EXAMINATION OR JOURNEYMAN GAS FITTERS EXAMINATION, THE BOARD MAY RENEW THE APPRENTICE PLUMBER LICENSE OR APPRENTICE NATURAL GAS FITTERS LICENSE FOR AN ADDITIONAL 2-YEAR TERM FOR EACH FAILED EXAMINATION.

~~(a) (1) Subject to the hearing provisions of § 12-313 of this subtitle, the Board may deny a license to any applicant, reprimand any licensee, or suspend or revoke a license if the applicant or licensee:~~

~~(i) fraudulently or deceptively obtains or attempts to obtain a license for the applicant or licensee or for another;~~

~~(ii) fraudulently or deceptively uses a license;~~

~~(iii) is guilty of gross negligence, incompetence, or misconduct while providing plumbing services or assisting in providing plumbing services;~~

~~(iv) is guilty of violating the State Plumbing Code or applicable local plumbing code while providing plumbing services or assisting in providing plumbing services;~~

~~(v) under the laws of the United States or of any state, is convicted of:~~

~~1. a felony; or~~

~~2. a misdemeanor that is directly related to the fitness and qualification of the applicant or licensee to provide plumbing services;~~

1                   (vi) ~~is guilty of an unfair or deceptive trade practice, as defined~~  
2 ~~in § 13-301 of the Commercial Law Article;~~

3                   (vii) ~~fails to train and control adequately any person who, while~~  
4 ~~under the direction and control of the master plumber or holder of a limited master~~  
5 ~~plumber license, sells or gives estimates for providing plumbing services or provides or~~  
6 ~~assists in providing plumbing services;~~

7                   (viii) ~~fails to maintain the liability insurance required under §~~  
8 ~~12-501 of this title for a master plumber, holder of a limited master plumber license~~  
9 ~~who contracts to provide plumbing services on behalf of the master plumber, holder of~~  
10 ~~a limited master plumber license, or another, holder of a propane gas fitter certificate,~~

13                   (x) ~~as the holder of a limited license, propane gas fitter~~  
14 ~~certificate, master natural gas fitters license, journey plumber license, journeyman~~  
15 ~~natural gas fitters license, apprentice plumber license, or apprentice natural gas~~  
16 ~~fitters license, performs plumbing, propane gas fitting, or natural gas fitting services~~
