A BILL ENTITLED

1 AN ACT concerning

2 **Housing Authorities – Consolidation or Merger – Talbot County and St.**
3 **Michaels**

4 FOR the purpose of authorizing the Housing Commission of Talbot County and the St.
5 Michaels Housing Authority to unite by consolidation or merger to form one
6 authority under certain circumstances; requiring the unification of the Housing
7 Commission of Talbot County and the St. Michaels Housing Authority to be
8 initiated by the passage of a certain proposal of unification by the legislative
9 body of certain municipal corporations; requiring the appointment of a certain
10 commission to draft proposed articles of organization for a proposed authority
11 under certain circumstances; imposing certain duties on a certain commission;
12 providing that the legislative body of each municipal corporation must adopt or
13 reject certain articles of organization as a whole; prohibiting the articles of
14 organization from being amended or changed except under certain
15 circumstances; requiring a certain custodian of records to file certain articles of
16 organization with the Secretary of State under certain circumstances; requiring
17 the Secretary of State to issue a certificate of approval for certain articles of
18 organization under certain circumstances; prohibiting an authority created
19 under this Act from doing business or exercising its powers unless a certain
20 certificate has been issued; defining certain terms; and generally relating to the
21 consolidation or merger of the Housing Commission of Talbot County and the
22 St. Michaels Housing Authority.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
5 MARYLAND, That the Laws of Maryland read as follows:

6 **Article – Housing and Community Development**

7 12–105.

8 (a) An authority of a municipal corporation or Baltimore City may:

9 (1) operate within its territorial boundaries; and

10 (2) without regard to location:

11 (i) administer rent subsidy payments and housing assistance
12 programs for both eligible landlords and tenants;

13 (ii) own or manage housing projects in operation before January
14 1, 1990; and

15 (iii) develop, own, or operate a housing project at the request of
16 and within the territorial boundaries of another political subdivision.

17 (b) (1) Anywhere in its county an authority of a county may:

18 (i) administer rent subsidy payments and housing assistance
19 programs for both eligible landlords and tenants; and

20 (ii) own or manage housing projects in operation before:

21 1. January 1, 1990, if the authority is of Baltimore City;

22 or

23 2. January 1, 1991, if the authority is of another county.

24 (2) Subject to paragraph (3) of this subsection, an authority of a county
25 may conduct its other operations within the county.

26 (3) An authority of a county other than Baltimore City may not
27 conduct its other operations within a municipal corporation unless the governing body
28 of the municipal corporation consents by resolution to its inclusion in the authority's
29 area of operation.

1 **(C) AN AUTHORITY CREATED UNDER § 12-208 OF THIS TITLE MAY**
2 **CONDUCT ITS OPERATIONS IN THE AREA PRESCRIBED UNDER ITS ARTICLES OF**
3 **ORGANIZATION.**

4 12-201.

5 **[In] EXCEPT AS PROVIDED IN § 12-208 OF THIS SUBTITLE, IN** each political
6 subdivision, there is a public body corporate and politic known as the “housing
7 authority” of the political subdivision or as otherwise designated in the articles of
8 organization.

9 12-204.

10 **(a) [Each] EXCEPT AS PROVIDED IN § 12-208 OF THIS SUBTITLE, EACH**
11 **pre-existing authority continues to exist.**

12 **12-208.**

13 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**
14 **MEANINGS INDICATED.**

15 **(2) “CONSOLIDATION” MEANS THE DISSOLUTION OF SEPARATE**
16 **EXISTING AUTHORITIES AND THE SIMULTANEOUS CREATION OF A NEW**
17 **AUTHORITY.**

18 **(3) “MERGER” MEANS THE ABSORPTION OF ONE EXISTING**
19 **AUTHORITY BY ANOTHER EXISTING AUTHORITY IN WHICH THE ONE AUTHORITY**
20 **DISSOLVES AND THE OTHER AUTHORITY CONTINUES TO EXIST.**

21 **(B) THE HOUSING COMMISSION OF TALBOT COUNTY AND THE ST.**
22 **MICHAELS HOUSING AUTHORITY MAY UNITE BY CONSOLIDATION OR MERGER**
23 **TO FORM ONE AUTHORITY.**

24 **(C) (1) THE UNIFICATION OF THE HOUSING COMMISSION OF TALBOT**
25 **COUNTY AND THE ST. MICHAELS HOUSING AUTHORITY SHALL BE INITIATED BY**
26 **THE PASSAGE OF A PROPOSAL OF UNIFICATION IN SUBSTANTIALLY THE SAME**
27 **FORM BY THE LEGISLATIVE BODY OF THE TOWN OF EASTON AND THE**
28 **LEGISLATIVE BODY OF THE TOWN OF ST. MICHAELS.**

29 **(2) THE PROPOSAL OF UNIFICATION SHALL:**

30 **(I) INCLUDE A DESCRIPTION OF THE BOUNDARIES OF THE**
31 **AREA OF OPERATION FOR THE PROPOSED AUTHORITY; AND**

1 **(II) BE APPROVED BY EACH MUNICIPAL CORPORATION IN**
2 **THE SAME MANNER PROVIDED FOR THE ADOPTION OF A RESOLUTION OR**
3 **ORDINANCE IN THE CHARTER OR BYLAWS OF THE MUNICIPAL CORPORATION**
4 **THAT IS CONSIDERING THE PROPOSAL OF UNIFICATION.**

5 **(D) (1) AFTER BOTH MUNICIPAL CORPORATIONS APPROVE A**
6 **PROPOSAL OF UNIFICATION, EACH MUNICIPAL CORPORATION SHALL APPOINT**
7 **AN EQUAL NUMBER OF REPRESENTATIVES, WHICH MAY NOT BE LESS THAN**
8 **THREE NOR MORE THAN FIVE, TO A COMMISSION CHARGED WITH DRAFTING**
9 **ARTICLES OF ORGANIZATION FOR THE PROPOSED AUTHORITY.**

10 **(2) THE MEMBERS OF THE COMMISSION SHALL:**

11 **(I) ADOPT RULES AND ELECT OFFICERS TO GOVERN THEIR**
12 **MEETINGS AND EXPEDITE THE DRAFTING OF THE ARTICLES OF ORGANIZATION;**
13 **AND**

14 **(II) COMPLETE A DRAFT OF THE ARTICLES OF**
15 **ORGANIZATION NO LATER THAN 6 MONTHS AFTER THE APPROVAL OF THE**
16 **PROPOSALS OF UNIFICATION.**

17 **(3) IN THE DRAFT ARTICLES OF ORGANIZATION OR IN A**
18 **SEPARATE DOCUMENT, THE COMMISSION SHALL:**

19 **(I) DESCRIBE THE BOUNDARIES OF THE AREA OF**
20 **OPERATION FOR THE PROPOSED AUTHORITY; AND**

21 **(II) PROVIDE FOR:**

22 **1. THE DISPOSITION OF ANY DEBTS, BONDS, AND**
23 **OTHER OBLIGATIONS OF THE HOUSING COMMISSION OF TALBOT COUNTY AND**
24 **ANY DEBTS, BONDS, AND OTHER OBLIGATIONS OF THE ST. MICHAELS HOUSING**
25 **AUTHORITY;**

26 **2. THE TRANSFER TO THE PROPOSED AUTHORITY OF**
27 **ANY PROPERTY AND OTHER ASSETS OF THE HOUSING COMMISSION OF TALBOT**
28 **COUNTY AND ANY PROPERTY AND OTHER ASSETS OF THE ST. MICHAELS**
29 **HOUSING AUTHORITY; AND**

30 **3. THE DESIGNATION OF THE CHIEF ELECTED**
31 **OFFICIAL, CUSTODIAN OF RECORDS, AND LEGISLATIVE BODY OF WHICH**
32 **MUNICIPAL CORPORATION THAT SHALL GOVERN THE OPERATIONS OF THE**
33 **PROPOSED AUTHORITY.**

1 **(E) (1) THE COMMISSION CREATED UNDER SUBSECTION (D) OF THIS**
2 **SECTION SHALL SUBMIT THE DRAFT ARTICLES OF ORGANIZATION TO THE**
3 **LEGISLATIVE BODY OF EACH MUNICIPAL CORPORATION FOR ADOPTION OR**
4 **REJECTION.**

5 **(2) THE LEGISLATIVE BODY OF EACH MUNICIPAL CORPORATION**
6 **MUST ADOPT OR REJECT THE DRAFT ARTICLES OF ORGANIZATION AS A WHOLE.**

7 **(3) NO AMENDMENT OR CHANGE MAY BE MADE TO THE DRAFT**
8 **ARTICLES OF ORGANIZATION UNLESS THE LEGISLATIVE BODY OF EACH**
9 **MUNICIPAL CORPORATION CONCURS IN THE AMENDMENT OR CHANGE.**

10 **(4) IF THE LEGISLATIVE BODY OF EACH MUNICIPAL**
11 **CORPORATION ADOPTS THE DRAFT ARTICLES OF ORGANIZATION, THE**
12 **APPROPRIATE CUSTODIAN OF RECORDS SHALL FILE THE ARTICLES OF**
13 **ORGANIZATION WITH THE SECRETARY OF STATE.**

14 **(F) (1) IF THE SECRETARY OF STATE FINDS THAT THE APPROPRIATE**
15 **REQUIREMENTS OF §§ 12-205 AND 12-206 OF THIS SUBTITLE HAVE BEEN**
16 **SATISFIED, THE SECRETARY OF STATE SHALL ENDORSE THE ARTICLES AS**
17 **“APPROVED” AND ISSUE A CERTIFICATE OF APPROVAL ATTACHED TO THE**
18 **ENDORSED ARTICLES OF ORGANIZATION.**

19 **(2) WHEN THE CERTIFICATE OF APPROVAL IS ISSUED, THE**
20 **ARTICLES OF ORGANIZATION AS FILED ARE CONSIDERED TO HAVE BEEN**
21 **ADOPTED.**

22 **(3) AN AUTHORITY CREATED UNDER THIS SECTION MAY NOT DO**
23 **BUSINESS OR EXERCISE ITS POWERS UNLESS THE SECRETARY OF STATE HAS**
24 **ISSUED A CERTIFICATE OF APPROVAL.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2011.
